Human Rights Commission Business Meeting Minutes

HRC Chairperson Shell called the meeting to order at 6:34 pm.

Roll Call was taken. A quorum was present.

Agenda Approval

Commissioner Reese called for a motion to approve the HRC Business Meeting Agenda of December 15, 2016. The motion was seconded and carried.

Approval of Minutes

Commissioner Cervantes made a motion to approve the December 15th minutes (there was not a quorum for the January meeting) – the motion was subsequently carried.

NEW BUSINESS:

<u>Creating Statutory Subcommittees (called Steering Committees)</u>

Individual motions were made to create the following statutory subcommittees, with membership to be determined. The proposed subcommittees will be called:

Education/Outreach Steering Committee Advocacy and Policy Steering Committee Prevention and Intervention Steering Committee

Individual motions were made to create all three statutory subcommittees, and each motion carried by majority vote.

Reduce Size of Commission from 15 Members to 11 Members

A motion was made to recommend reducing the size of the Human Rights Committee from 15 commissioners to 11 commissioners. The recommendation would be made by OEHR staff to the City Council and/or the appropriate council committee. The motion carried by majority vote.

Statutory Definition of Sexual Orientation and Gender Identity in TMC 1.29

- A motion was made to take the staff's proposed revisions to the definition of Sexual Orientation and Gender Identity in TMC 1.29 to the City Council for consideration.
- Commissioner Cervantes noted that the current definitions of Sexual Orientation and Gender Identity in TMC 1.29 and in Washington State's anti-discrimination statute represent ideal language. Commissioner Cervantes recommended more up-to-date language as published by the Human Rights Campaign.
- Human Rights Manager Armstrong noted that the definition from the State of Washington strikes a balance between an open and inclusive definition and a definition that is enforceable given that the definition could be used to determine potential complainants in a human rights complaint.
- Commissioners Reese and Brogan expressed concerns with linking gender identity/expression so closely to sexual orientation as done in the State's language. Example: there are many people who are not heterosexual but have very normative gender expression – the language should be enforceable but may also benefit from separation.
- The motion to recommend changes to the aforementioned definitions was withdrawn by Chairperson Shell, and not voted on by the Commission.
- Chairperson Shell moved that the issue be considered by the newly created Policy and Advocacy Steering Committee. The motion passed.
