#### **Public Comment**

#### **Chair Reports**

- **LNG Hearing** – Chair Lemons felt the event was intense; the Puyallup tribe has coordinated a march to the event. There were a number of people speaking on both sides of the issue. People ranging from scientist, professors, and engineers all speaking with wealth of knowledge in this area.
- **South Sound Solidarity Social-** Event hosted by the Northwest Immigrant Rights Project (NWIRP). Lots of people who work with detainees at the Northwest Detention Center. Powerful and exciting.

- **Addressing homelessness in Pierce County** –Human services division, funding comes from HUD. Discussions around the various issues and topics have been discussed for around 18 years in Pierce County. Through discussion with others on the committee, the consensus feels that the plans are being rushed and not fully evaluated and look through the different channels. A plan is in the works towards being finalized in December, with a five year plan that will layout the continuum of care.  
**Staff Armstrong** – Ms. Armstrong discussed how the landlord tenant rights started from issues that came from the new owners of the Tiki apartments. Ordinance for the tenants and developers to allow more time, and the city provided relocation funding. The permanent fix was to have a series of meetings with landlords and tenants, and what can both parties live with knowing the landlords are in the business of business, hopefully to be part of the solution towards the larger issues.
- **City Council Candidate Forum on Affordable Housing** – was also attended by **Commissioner Snyder**. Ms. Snyder mentioned her brother in law is running. Candidates were given questions before the forum. Candidates discussed issues around how we can appeal better to developers.
