We have a very full agenda including review of TAIP and Anchor Fund guidelines, funding distribution and Executive Committee elections. We have summarized the issues and proposed changes and ask that you please read this over and review the guidelines in advance so we are sure to get through the agenda in a timely manner. Clarifying information about these items can be found below.

## **COMMISSION EXECUTIVE COMMITTEE ELECTIONS**

We have received and confirmed nominations for the 2017 Chair and Vice Chair positions as follows:

- Chair nominations Mike Sweney
- Vice Chair nominations Rachel Cardwell

You will vote on these positions at the meeting.

## 2017-18 FUNDING DISTRIBUTION

It is the Arts Commission's role to determine the distribution of funds to each of our funding programs (Arts Anchor Fund, Arts Projects, and Tacoma Artists Initiative Program) from the allocation identified. At this point, we do not have a confirmed funding allocation for re-distribution in 2017-18 but are planning on \$395,000 (the same amount as we had in the last two budget cycles.)

For context, in 2013-14 and 2015-16, the Commission redistributed the \$395,000 funding allocation as follows:

\$40,000 Tacoma Artists Initiative Program	10%
• \$100,000 Arts Projects (\$50,000 per year)	25%
• \$255,000 Anchor Fund	65%

For 2017-18, staff recommends maintaining the same distribution levels as used in 2015-16.

It will also shave days off of staff time in processing applications and will allow us to get application packet materials out to the panelists much easier. - On Pages 5 & 6 of the application (pages 11 & 13 of the PDF) We will now accept digital files or URLs (not DVDs) for Performance or New Media work samples. We will now accept digital files or URLs (not CDs) for Music/Sound Art work samples.

- On Page 6 of the application (page 11 of the PDF) Moving the Operating Deficit
   Explanation Sheet out of the Application Narrative and making it part of the online application form
- On Pages 7 & 8 of the application (pages 15 & 17 of the PDF) We will now accept digital files or URLs (not DVDs) for Performance or New Media work samples. We will now accept digital files or URLs (not CDs) for Music/Sound Art work samples.
