- Plan initial budget cuts for projected 2020 shortfall
- O Contracted partners are notified that there will not be a competitive process for 2021
- May
- o Staff furloughs of five weeks begin, all staff rotate through end of July
- Neighborhood Council funding and Innovative Grants are withheld due to budgetary impacts
- June
- City Council passes <u>resolution 40622</u> focusing on transformative efforts to improve equity in service delivery
- Re-location of Tacoma Emergency Micro-Shelters (TEMS) at 8<sup>th</sup> and MLK to 60<sup>th</sup> and McKinley
- July
- Departments begin biennial budget planning
- August
  - NCS Accepts federal funding (ESG CV-2) to support non-congregate sheltering for individuals experiencing homelessness
- September
  - o Homelessness Program Update
  - o Work on TEMS at 602 N Orchard begins
  - o New HSC staff support (Kristin Ely and Allyson Griffith)
  - o COVID-19 Digital Infrastructure Awards are made to 22 organizations

Linda Stewart shared updates

City is working toward transformation from a DEI perspective, continuity of services, and a strong pandemic response. These three priorities drove the development of the 2021 budget.

The city of Tacoma has a \$40 million dollar revenue shortfall. Council is examining a 10% reduction across the board for the budget.

No competitive process for 2021 for organizations. The Human Services Commission will need to be engaged in a different way. There will be an effort with first time funded organizations where they will apply and be reviewed. Put contracts in place for 2 years for non profits. \$1.3 million dollar reduction in MHSUD. With the focus on shelter, there will reductions elsewhere.

For now, HSC is asked to support the recommendations of the staff in continuing to fund existing organizations.

Priorities will include shelter, pandemic response, and DEI transformation.

Naomi made a motion to accept moving our HSC meeting from November 11<sup>th</sup> to November 4<sup>th</sup> to hear the recommendations for budget reductions. Elizabeth seconded, and it was unanimously approved by Vice Chair Zach Dillon, Secretary Kelly McDonald, Jason Grube, Lisa Keating, Cherrielee Matthews, Elizabeth Pebley, Amanda Scott-Thomas, Valentine Smith, Naomi Wilson.

Allyson shared the 9 buckets for funding with Commissioners. The majority of funding falls in shelter at 29%. On November 4<sup>th</sup>, the city staff will present Commissioners with how the City can support existing organizations within those buckets.
