7. Hygiene Station Pilot Project

• Allyson Griffith presented that NCS staff worked with 1-800-Junk to establish a pilot project hygiene station for 30 days at 8th and S Yakima. The pilot will run from March 5-April 7 and

services include portable toilets, handwashing stations, trash receptacles and evening/overnight security from 6pm-6am daily.

- Commissioner Wilson asked about shower availability. Showers are available through shelter providers and we will circle back on availability for those living in encampments.
- Commissioner Stickel asked about the transition from five sites to a single site. The primary concern was over the cost and use of multiple sites. We are assessing whether or not the encampment grows surrounding area to the hygiene stations.
- Chair Clayton recommended going back to listen to the study session and council meeting conversations on February 2,9 and 23rd where this topic was discussed.
- Commissioner Wilson asked what is our measure of success, which Allyson responded is a reduction in complaints regarding vandalism or biohazards on private property or right-of-way. We would also evaluate success about whether or not the services are properly utilized.
- Commissioner Keating asked if we have contacted Tacoma Public Schools, which we did. NCS staff contact 619 individuals via email and made 200 phone calls to nearby neighbors.

8. NCS Program Updates

May HSC Commissioner Recruitment → Applications are now open through March 28, 2021 for 5 vacancies. Commissioners Dumas, Ray, Stickel, and Keating have expiring positions on May 31, 2021. We continue to have a youth vacancy (16-18 years old, one year term).

9. CDBG/ESG 2021-2022 Allocations

• NCS Resource Manager Jason McKenzie presented on NCS' recommendation to extend funding for 6 months for currently funded providers and for the HSC to work on developing a recommendation to move forward for the second half of the funding cycle which is January 2022-June 2022. Staff will re-visit this item in a few months with the commission to develop establish next steps for funding allocations.

10. Youth Violence Reduction Logic Model

- Commissioner Scott-Thomas is curious about youth voice and how it has been included. Renee Johnson with NCS will be reaching out directly to discuss connecting with subject matter experts who can give input.
- Commissioner Wilson has questions about trauma informed care and wants to make sure that funded providers have access to these trainings in order to support this work
