

Designating the Highlands Golf Course, located in West Tacoma, as open space for property tax purposes under the City and County's Open Space Current Use Assessment program, together with a recommendation regarding the appropriate property tax discount, and appointing Tacoma City Council members Fey, Manthou and Walker to serve on a Joint Determining Authority with three Pierce County Council members, who will make a final decision on the application should the City and County differ in their respective recommendations.

7. BACKGROUND INFORMATION/GENERAL DISCUSSION: (Why is this request necessary? Are there legal requirements? What are the viable alternatives? Who has been involved in the process?)

Highlands Twenty LLC submitted an application concerning an Open Space Current Use Assessment for the approximately twenty-acre Highlands Golf Course consisting of five parcels and located in West Tacoma north of State Route 16, south of Westgate Boulevard and west of North Pearl Street. The proposed designation as open space would not affect the City's planning or regulatory classifications for the property, but could reduce the property taxes assessed to the golf course on an ongoing basis, contingent upon its continued use as an open space and recreation area. State law provides for such classifications in cases where the conservation of land as open space constitutes a benefit to the general public. The City Council and County Council jointly review Current Use Assessment applications, per RCW 84.34; the final action on this application will be by separate concurring decisions from both the City and the County, or by a Joint Determining Authority composed of three members of each Council in the event of differing recommendations.

The Planning Commission, in accordance with Tacoma Municipal Code Chapter 13.08, held a public hearing on October 14, 2009 and recommends that four of the five parcels be classified as open space and consequently receive a 60 percent property tax reduction. The Commission determined that this reduction was proportional to the public benefits derived from the golf course, which contains three wetlands and provides open space and recreational opportunities to the community.
