All other provision and specifications of this section remain intact. Any notation of bird netting within the drawings are hereby amended to include this amendment to the specifications

QUESTIONS AND ANSWERS:

Question 1: Is there a laydown/staging area for this project?

Answer 1: The only laydown area the City has available would be the lower level of the

existing building. Any additional laydown area would require the contractor to

obtain sidewalk or right of way closer permits from the City

Question 2: Will the tree limbs that touch the building be trimmed?

Answer 2: The City employs an arborist and will conduct any necessary tree trimming prior

to construction. Please note that the City can only trim limbs that are entering the

City's property.

Question 3: Will the building be accessible from the parking lot on the south side of the

building?

Answer 3: The City is working with the neighboring owner to use the parking spaces

adjacent to our building for a period of 4 to 5 weeks during construction for

building access.
