6. <u>Loan write off- Brown</u> (Presenter: Cathy Morton)
Staff recommended TCRA write off a loan with a remaining balance of \$4,728.00 following a short sale payoff.

7. Housing Development Application Recommendations (Presenter: Cathy Morton)

Staff recommended the board award funds to two housing developers which requested funding under the current solicitation for housing development applications. The requests were associated with Tacoma Housing Authority's Bay Terrace, Phase II, and MacDonald Ladd Development's Oak Trace.

MOTION: Matt LaCroix moved to approve the Tacoma Housing Authority's Bay Terrace, Phase II request. Jason Kors seconded the motion. The motion passed unanimously.

MOTION: Michael McNiel moved to approve MacDonald Ladd Development's Oak Trace request. Helen Tran seconded the motion. The motion passed unanimously on condition of a favorable environmental assessment, specifically as it concerns existing oak trees on the property.

8. Attorney General Program Target Areas (Presenter: Cathy Morton)

Per the board's Nov. 20, 2014 request and for the board's reference, staff provided a map of the three areas targeted under the Attorney General Program.
