# PIERCE COUNTY ENHANCED 9-1-1 PSAP PARTICIPATION AGREEMENT AMENDMENT

The "PSAP PARTICIPATION AGREEMENT" signed for the year 2006 by Pierce County and the City of Tacoma Fire Department is hereby amended to change paragraph B. <u>Duration</u> for a renewal of one year to end December 31, 2012, and Attachment B which will include a new Distributed Funds Schedule, and to continue paragraph D. 9. Reporting requirements, as first added in 2010.

This Agreement continues in its entirety, except substituting the newly revised Attachment B, and the following paragraph B. <u>Duration</u> for the existing Attachment and paragraph B; and continuing the following paragraph D. 9.:

### B. DURATION:

This Agreement is renewed for a term of one (1) year, commencing January 1, 2012, and ending December 31, 2012, and may be renewed beyond that date, in one year increments. Any party shall have the right to withdraw from this Agreement by giving written notice to the County, prior to October 1, of each year, of its intent to withdraw at the close of the year, except that the County shall give its written notice to the appropriate designated representative for the PSAP.

#### D. RESPONSIBILITY OF THE PSAP:

9. Provide the E911 Program Office with: Monthly call Volume Report no later than 30 days following the end of each month; Equipment list including copy of any maintenance agreements by June 1, each year; Annual Salary Report based on previous calendar year by June 1, each year; Submit Amendment Reimbursement requests (if any) by November 30, each year; and in addition, the E911 Program Office may request additional reports.

The person signing this Agreement on behalf of each party has been properly authorized and empowered to enter into this Agreement. Each party further acknowledges that it has read this Agreement, understands it, and agrees to be bound by it. # DISTRIBUTED FUNDS SCHEDULE:

For the Calendar year 2012, E911 funds shall be distributed to the PSAP's as follows:

The City of Buckley PSAP shall receive \$963.00 per month, \$11,556.00 for the year.

The City of Fife PSAP shall receive \$863.00 per month, \$10,356.00 for the year.

The Law Enforcement Support Agency PSAP shall receive \$86,858.00 per month, \$1,042,296.00 for the year.

The Pierce County Fire District #2 PSAP shall receive \$24,509.00 per month, \$294,108.00 for the year.

The City of Puyallup PSAP shall receive \$6,294.00 per month, \$75,528.00 for the year.

The City of Tacoma Fire Department PSAP shall receive \$19,335.00 per month, \$232,020.00 for the year.

Only those PSAPs listed herein shall receive any distributed funds from the Piece County E911 funds.
