The Tacoma City Council, at its regular City Council meeting of May 21, 2013, adopted the following resolutions and/or ordinances. # **Purchase Resolution No. 38676**

Awarding contracts to:

1.Northwest Cascade, Inc., on its bid of \$584,520.25, plus sales tax and a 10 percent contingency, for a cumulative total of \$642,972.28, budgeted from the Streets Special Revenue Fund, for roadway repair on South 25th Street from Jefferson Avenue to C Street – Specification No. PW12-0469F;

2.Capital Industries, Inc., on its bid of \$522,925.00, sales tax not applicable, budgeted from the Solid Waste Fund, for metal solid waste and recycle containers, for an initial two-year term, with the option to renew for three additional one-year terms, for a projected contract total of \$1,307,312.50 – Specification No. ES13-0131F; and

3.Midvale Electric, Inc., in the amount of \$140,000.00, plus sales tax, budgeted from the Public Works Tacoma Rail Mountain Division Fund, for a cumulative total of \$993,380.00, to increase and extend the contract for continued federally mandated grade crossing system signal inspections and maintenance through June 30, 2014 – Specification No. TR10-0129F.

**<u>RECOMMENDATION</u>**: The Public Works Engineering Division recommends a contract be awarded to low bidder **Northwest Cascade**, **Inc.**, **Puyallup**, **WA**, for roadway repair on South 25th Street from Jefferson Avenue to C Street. The contract amount reflects a total award of \$584,520.25, plus sales tax, plus 10% contingency for a cumulative amount of \$642,972.28, plus sales tax.

**EXPLANATION:** This contract provides for new cement concrete sidewalk and driveways, curb and gutter, curb ramps, re-grading the road, grind and overlay, and miscellaneous utility work on South 25th Street from Jefferson Avenue to C Street.

**<u>COMPETITIVE SOLICITATION</u>:** Request for Bids Specification No. PW12-0469F was opened April 2, 2013. Following the normal advertising standards for City of Tacoma projects, six submittals were received. The table below reflects the amount of the total award.

The recommended award is 11.4 percent below the pre-bid estimate.

#### CONTRACT HISTORY: New contract.

**<u>FUNDING</u>**: Funds are budgeted in the Streets Special Rev Fund 1060. Funding beyond the current blennium is subject to future availability of funds.

**<u>SUSTAINABILITY</u>:** This project will improve roadway surfaces for pedestrian and bicycle access between neighborhood business districts and downtown Tacoma. Installing new ADA ramps in high traffic areas, UW Tacoma, and high traffic pedestrian locations will enhance safety and attract more people to Tacoma. This project also builds a part of the Prairie Line Trail along South 25th Street.

**DISADVANTAGED BUSINESS ENTERPRISE (DBE):** The recommomended contract is in compliance with 49 Code of Federal Regulations Part 26, per memorandum dated April 17, 2013. The DBE goal for this project is ten percent; the DBE participation is 11.37 percent. The City has designated zero training hours for this project.

The Public Works Engineering Division is requesting City Council award a contract to low bidder Northwest Cascade, Inc., of Puyallup, WA, for roadway repair on South 25<sup>th</sup> Street from Jefferson Avenue to C Street. The contract amount reflects a total award of \$584,520.25, plus sales tax, plus a 10% contingency for a cumulative amount of \$642,972.28, plus sales tax.

#### **Background**

In March 2007, the City was awarded a \$2,259,865 grant from the Washington State Department of Transportation (WSDOT) to replace deteriorated asphalt pavement, repair and replace curb and gutter, and install new ADA ramps and sidewalks on Pacific Avenue from South 17<sup>th</sup> Street to South 25<sup>th</sup> Street and on South 25<sup>th</sup> Street from Pacific Avenue to South C Street. This project had multiple funding sources with a total project budget of \$2,751,561.

In July 2008, a contract was awarded to Johansen Excavating, Inc. in the amount of \$1,922,739, plus sales tax. At the time this project was nearing completion, additional grant and local funds became available. In March 2011, the City was authorized to use the additional funds to extend the improvements on South 25<sup>th</sup> Street from South C Street to Jefferson Avenue. This additional work was scheduled to start after the completion of the Sound Transit D-M Commuter Rail project.

Design for the additional scope of work was completed in 2013, and the project advertised on March 12, 2013. This project includes additional cement concrete sidewalk and driveways, curb and gutter, ADA ramps, asphalt pavement grind and overlay, and miscellaneous utility work. This project will also construct a portion of the Prairie Line Trail along South 25<sup>th</sup> Street. Roadway repair costs will be shared between Public Works and Environmental Services. Environmental Services will fund sewer utility costs.



**RECOMMENDATION:** The Environmental Services Department, Solid Waste Management (SWM) Division recommends a contract be awarded to second low bidder Capital Industries. Inc., Seattle, WA, for the purchase of metal solid waste and recycle containers. This is an initial two-year contract, in the amount of \$522,925.00, sales tax not applicable, with the option to renew for three additional one-year renewals for a cumulative amount of \$1,307,312.50, sales tax not applicable.

EXPLANATION: SWM provides commercial recycling and disposal services using metal containers that vary in size from 2 to 8 cubic yards for front-load solid waste and recycle containers and 15 to 40 cubic yards for solid waste drop-off boxes. The purchase of these containers will be used to replace aging containers, replenish existing stock and allow SWM to continue to provide this service to our customers.

COMPETITIVE SOLICITATION: Request for Bids Specification No. ES13-0131F was opened April 9, 2013. Five companies were invited to bid in addition to normal advertising of the project. Three submittals were received. The low bidder, Wastequip Mtg. Co., LLC, was not recommended for award because of an exception to the price adjustment requirements which made their bid noncompliant with the bid specification. The table below reflects the amount of the base award.

The Environmental Services Department, Solid Waste Management (SWM) Division requests a contract be awarded to Capital Industries, Inc., of Seattle, WA, for the purchase of metal solid waste and recycle containers. This is an initial two-year contract, in the amount of \$522,925.00, sales tax not applicable, with the option to renew for three additional one-year renewals for a cumulative amount of \$1,307,312.50, sales tax not applicable.

### **Background**

Request for Bids Specification No. ES13-0131F was opened April 9, 2013. Five companies were invited to bid in addition to normal advertising of the project. Three submittals were received. The low bidder, Wastequip Mtg. Co., LLC, was not recommended for award because their bid proposed an exception to the price adjustment requirements of the bid specification. The specification states that pricing shall be firm throughout the initial 24-month contract period and that the City will consider price adjustments for each subsequent 12-month contract period. Wastequip Mtg. Co., LLC proposed that price adjustments be allowed quarterly with language that could allow a change to the actual bid price as well. The proposed exception is not consistent with the language in the bid specification requiring a specific price adjustment schedule.

#### Reason for Action

SWM uses metal containers to provide service primarily to City commercial accounts. The metal containers vary in size from 2, 3, 4, 6 and 8-cubic yard front-load solid waste and recycle containers to 15, 20, 25, 30 and 40-cubic yard drop-off solid waste metal containers. The Recycle Center also utilizes the drop-off metal containers for the collection of recyclables. The front-load metal solid waste and recycle containers will allow SWM to expand the collection of commingled and cardboard recycle programs. The purchase of these containers will also be used to replace aging containers and replenish existing stock.

**RECOMMENDATION**: Public Works, Tacoma Rail Mountain Division requests approval to increase SAP contract 4600006382 to **Midvale Electric, Inc., Sunnyside, WA** by \$140,000.00, plus sales tax, for continued federally mandated grade crossing system signal inspections and maintenance. This increase will bring the contract to a cumulative total of \$993,380.00, plus sales tax.

**EXPLANATION:** This contract is for continued federally mandated periodic grade crossing signal system inspections and maintenance, as prescribed by 49 CFR Part 234.

**<u>COMPETITIVE BIDDING</u>**: This contract was originally awarded to Midvale Electric, Inc., as a result of Request for Bids Specification No. TR10-0129F in June 2010. The contractor has agreed to extend and increase the contract for one year at the same prices, terms, and conditions.

**<u>CONTRACT HISTORY</u>**: The original contract for \$660,930.00 plus sales tax was approved by City Council Resolution No. 38042 on June 8, 2010. The contract was amended May 22, 2012, through City Council Resolution No. 38491 increasing the value by \$192,450.00 and extending the contract term one year to June 30, 2013. This increase and extension will bring the contract to a cumulative total of \$993,380.00, plus sales tax, and extend the contract duration to June 30, 2014. This is the second of two renewals allowed under this contract.

**<u>SUSTAINABILITY</u>**: Midvale Electric supplies its signal maintainers/inspectors with Flex-Fuel vehicles for maintenance and inspections of TRMW's crossing signals. Midvale Electric also routinely recycles all wire, batteries, and other replaced components from the crossing signals.

**<u>FUNDING</u>**: Funds for this are available in the Public Works Mountain Division Fund 4120. Funding beyond the current biennium is subject to future availability of funds.
