RESOLUTION NO. 38984

A RESOLUTION relating to public safety; authorizing the execution of an Amended and Restated Interlocal Agreement for Communications Services to add the City of Puyallup as a Member Agency; authorize 63-20 financing; incorporate provisions relating to the responsibilities of member agencies in the event of future shortfalls in tax collections; and update outdated language.

WHEREAS, on June 21, 2011, the City Council adopted Resolution

No. 38279, authorizing the execution of an Interlocal Agreement for

Communications Services ("Agreement") between Pierce County, the City of

Tacoma, the City of Lakewood, and Pierce County Fire Protection District No. 3

(West Pierce Fire & Rescue) ("Member Agencies") for the purpose of providing

consolidated public safety communications services under a new emergency

communications agency entitled South Sound 9-1-1 Agency ("Agency"), and

WHEREAS, on the November 8, 2011, General Election ballot, Pierce County voters approved Proposition No. 1, authorizing a county-wide, one-tenth of one percent local sales and use tax to fund costs associated with financing, design, acquisition, construction, equipping, operating, maintaining, remodeling, repairing and re-equipping the county's 9-1-1 emergency communication system and facilities infrastructure, and

WHEREAS, since the adoption of the original Agreement, the Agency has been working to identify additional regional partners, and

WHEREAS the City of Fife was added as a Member Agency pursuant to Resolution No. 38527, adopted on August 21, 2012, and

WHEREAS a Participation Agreement with the City of Puyallup was

approved by the South Sound 911 Policy Board on May 28, 2014, and it is necessary to add the City of Puyallup as a Member Agency to the Agreement, and

WHEREAS Section 16C of the Agreement states that Pierce County can, at its discretion, issue bonds on behalf of the Agency for the purpose of financing the capital assets required by the Agency, but required, in part, that all Member Agencies would enter into formal signed agreements which would identify how the Agency would continue to meet its payment obligations if the dedicated sales tax ever became unavailable or insufficient, and

WHEREAS the Member Agencies entered into a Memorandum of Agreement on July 13, 2013, to facilitate the bonding of a regional radio upgrade, including radio network infrastructure, dispatch consoles, and public safety radios, and

WHEREAS the Agency has completed preliminary planning for the development of a consolidated regional dispatch and records center, and is contemplating utilizing a 63-20 financing methodology through Pierce County, and

WHEREAS the Member Agencies have also negotiated a number of additional amendments, to include authorizing 63-20 financing and incorporating similar provisions to the July 13, 2014, Memorandum of Agreement regarding the responsibilities of Member Agencies in the event of a future shortfall in tax collections; updates to outdated language due to completion of activities originally included in the Agreement; and changes to terminology; Now, Therefore,



BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

That the proper officers are hereby authorized to execute the Amended and Restated Interlocal Agreement for Communications Services to recognize the City of Puyallup as a Member Agency of South Sound 911; to add a section authorizing language for 63-20 financing; to incorporate provisions relating to the responsibilities of Member Agencies in the event of a future shortfall in tax collections; to update outdated language due to completion of activities originally included in the Interlocal Agreement; and to make changes to terminology, said document to be substantially in the form of the proposed amended interlocal agreement on file in the office of the City Clerk.

Section 7. That Section 1.12.640 of the Tacoma Municipal Code is hereby amended effective as provided by law, to read as follows:

1.12.640 Application of additional rates.

5099 A Wastewater Treatment Plant Assistant (CSC 5099), upon completion of 50 percent of the training modules toward a certificate, will be assigned an applied rate of 3 percent above their current step rate of pay, and upon attainment of a certificate, will be assigned an applied rate of 6 percent above their current step rate of pay. This application of rate will not be available to employees that are hired after the implementation date of the 2012-2016 collective bargaining agreement.



 5099, 5105, 5106 An employee in the classification of Wastewater Treatment Plant Assistant (CSC 5099), Wastewater Treatment Plant Maintenance Machinist (CSC 5105), or Senior Wastewater Treatment Plant Maintenance Machinist (CSC 5106) shall receive a maximum certification premium of 3 percent above his-or-hertheir base rate of pay for holding a Water Backflow Assembly Technician license and/or-a-Crane Operators certification.

* * *

5310 A Fabrication Welder (CSC 5310) will receive nonautomatic step 2 rate of pay when, at the sole discretion of management, the employee is determined to be responsible for the primary operation of a structural steel fabrication weld shop. <u>Effective January 1</u>, 2014, the current Fabrication Welder at Public Works Fleet Services – Fleet Operations will qualify for this step 2 rate of pay.

5310 A Fabrication Welder (CSC 5310) assigned to work on Resource Recovery Plant equipment located at the Resource Recovery Plant shall be paid an additional 5 percent above his or her regular rate of pay.

5310 Employees in the classification of Fabrication Welder (CSC 5310), in the Sewer Division, shall receive an additional 5 percent of the regular rate of pay per hour when welding in the grit or sedimentation tank or final clarifier.

5310 A Fabrication Welder (CSC 5310) shall receive an applied rate of 2 percent above his or hertheir regular rate of pay for holding a Washington Association of Building Officials (WABO) Structural Welder or AWS D1.1 Certification.

5310, 5332 A Heavy Equipment Mechanic (CSC 5332) or Fabrication Welder (CSC 5310) assigned to work <u>at Solid Waste Compactor Facilities on equipment located on the landfill</u> shall be paid an additional 5 percent above <u>his or hertheir</u> regular rate of pay while working on the landfill.

5330 A Vehicle and Equipment Shop Attendant (CSC 5330) assigned to work on Resource Recovery Plant equipment located at the Resource Recovery Plant shall be paid an additional 5 percent above his or her regular rate of pay. When assigned to work at Solid Waste Compactor Facilities on equipment located on the landfill, employees in the classification of Vehicle and Equipment Shop Attendant (CSC 5330) shall be paid an additional 5 percent above his or hertheir rate of pay while working on the landfill.

5330 Effective on and after January 1, 2001, or any time thereafter that aAn employee who meets the certification requirements established by the collective bargaining agreement, employees in the classification of Vehicle and Equipment Shop Attendant (CSC 5330) shall receive an additional 2 percent above his or hertheir regular rate of pay.

5330 Effective January 1, 2011, aA Vehicle and Equipment Shop Attendant (CSC 5330) assigned to the Fire Department, and who meets the certification requirements established by the collective bargaining agreement, will be eligible to receive a certification premium of 3 percent above his or hertheir base rate of pay.

5331 An Apprentice Automotive Mechanic assigned to the Washington State Apprentice Program shall be assigned a rate of pay based on the appropriate journey-level rate as determined by the working area to which assigned. The beginning rate of pay shall be not less than 60 percent nor more than 70 percent based on a determination of ability and training by the Washington State Apprenticeship and Training Council.

5332 See 5310, 5332.



5332 A Heavy Equipment Mechanic (CSC 5332) shall receive an applied rate of 5 percent above his or hertheir base rate of pay when, at the sole discretion of management, is assigned to act in a lead capacity on a defined project.

5332 A Heavy Equipment Mechanic assigned to work on Resource Recovery Plant equipment located at the Resource Recovery Plant shall be paid an additional 5 percent above his or her regular rate of pay.

5332, Effective on and after January 1, 2001, or any time thereafter that aAn employee who meets the certification requirements established by the collective bargaining agreement, employees in the classifications of Heavy Equipment Mechanic (CSC 5332) shall receive an additional 5 percent over his or hertheir regular rate of pay.

5334 Effective on and after January 1, 2001, or any time thereafter that aAn employee who meets the certification requirements established by the collective bargaining agreement, employees in the classification of Vehicle and Equipment Shop Supervisor (CSC 5334) shall receive an additional 5 percent above his or hertheir regular rate of pay.

5335 Effective on and after January 1, 2001, or any time thereafter that aAn employee who meets the certification requirements established by the collective bargaining agreement, employees in the classification of Fire and Marine Diesel Mechanic (CSC 5335) shall receive an additional 5 percent above his or hertheir regular rate of pay. Effective January 1, 2011, aA Fire and Marine Diesel Mechanic shall be eligible for an application of rate of an additional 2 percent, for a total of 7 percent above his or hertheir base rate, for holding both certifications outlined in the collective bargaining agreement.

5336 Effective on and after January 1, 2001, or any time thereafter that aAn employee who meets the certification requirements established by the collective bargaining agreement, employees in the classification of Fire and Marine Shop Supervisor (CSC 5336) shall receive an additional 5 percent above his or hertheir regular rate of pay.

<u>5336</u> Effective January 1, 2011, a<u>A</u> Fire and Marine Shop Supervisor (<u>CSC 5336</u>) shall be eligible for an application of rate of an additional 2 percent, for a total of 7 percent above <u>his or hertheir</u> base rate, for holding both certifications outlined in the collective bargaining agreement.

5338 An employee in the classification of Resource Recovery Mechanic (CSC 5338) shall receive a certification premium of 3 percent above his or hertheir base rate of pay for holding a Water Backflow Assembly Technician license.

L160 An employee assigned to work the graveyard shift at Public Works Fleets-shall be eligible for an application of rate of fifty cents (\$0.50) per hour for each hour worked on or after $2 \cdot 100$ hours.

<u>L160 An employee assigned to the Wastewater Treatment Plant, when welding in any confined space, shall be paid an additional 5 percent above their base rate of pay.</u>

Section 8. That Section 1.12.640 of the Tacoma Municipal Code is hereby

amended effective as provided by law, to read as follows:

6015 A PAF Maintenance Worker II (CSC 6015) assigned as a specialist to perform the work of a rigger, welder, or carpenter, and also assigned as lead shall will be compensated an additional 5 percent per hourat Step 6 for all hours where the specialty work is performed.

That Section 5 of this ordinance shall become effective July 1, 2015. That Section 6 of this ordinance shall become effective July 1, 2016.
