between the McMillin Reservoir and Green River Watershed, and

WHEREAS George and Mary Roach have offered to purchase the Property for \$325,000, which is deemed acceptable by Tacoma Water and the Department of Public Works, Real Property Services Division, and

WHEREAS the Department of Public Works proceeded with the negotiated disposition process pursuant to Tacoma Municipal Code ("TMC") 1.06.280.F, and

"Tacoma Water"); authorizing the sale of approximately 0.89 of an acre of unimproved real property owned by the City of Tacoma, through its Department of Public Utilities, Water Division, and now surplus to its needs. to the Tacoma School District for the sum of \$5,000 and certain public benefits.

WHEREAS the City of Tacoma, through its Department of Public Utilities, Water Division (d.b.a. "Tacoma Water"), owns approximately 0.89 of an acre of unimproved property located near South Cedar Street in Tacoma, Washington ("Property"), and

WHEREAS the Property runs through the middle of the Tacoma School District's ("District") Arlington Elementary School site, and

WHEREAS, since 1953, the District has used a portion of the Property for various activities related to its operation of the school under the terms and conditions set forth in a use permit between the parties, and

WHEREAS the District is in the process of remodeling the school, and desires to purchase that portion of the Property located within the school site, and

WHEREAS Tacoma Water has determined that the Property sought by the District is not essential for continued effective utility service, and

WHEREAS the Department of Public Works, Real Property Services Division, has valued the Property at \$30,000, and

WHEREAS Tacoma Water has agreed to sell the Property to the District for \$5,000 in cash and \$25,000 in improvements, said improvements to consist of



 establishment of a rain garden and the production of related educational programs of benefit to Tacoma Water, and

WHEREAS, on July 27, 2016, by adoption of Public Utility Board Resolution No. U-10866, the Property was declared surplus to Tacoma Water's needs and approved for sale, pending confirmation from the City Council, and

WHEREAS, on August 16, 2016, the City Council held a public hearing for the purpose of receiving public testimony on the proposed sale of the subject Property, and no comments were received; Now, Therefore,

A RESOLUTION relating to the multi-family property tax exemption program; authorizing the execution of a Multi-Family Housing Eight-Year Limited Property Tax Exemption Agreement with Point Ruston Baker Building, LLC, for the development of 178 multi-family market-rate housing units to be located at 4851-4961 Main Street in the Point Ruston Mixed-Use Center.

WHEREAS the City has, pursuant to chapter 84.14 of the Revised Code of Washington, designated several Residential Target Areas for the allowance of a limited property tax exemption for new multi-family residential housing, and

WHEREAS the City has, through Ordinance No. 25789, enacted a program whereby property owners in Residential Target Areas may qualify for a Final Certificate of Tax Exemption which certifies to the Pierce County Assessor-Treasurer that the owner is eligible to receive a limited property tax exemption, and

WHEREAS Point Ruston Baker Building, LLC, is proposing to develop 178 new multi-family market-rate units to consist of 52 one-bedroom, one bath units, ranging in size from 502-837 square feet and renting for \$950-1,800 per month; 42 two-bedroom, two-bath units, ranging in size from 800-1,079 square feet and renting for \$1,450-2,500 per month; and 84 condominiums for sale, consisting of 73 two-bedroom, two-bath units ranging in size from 1,171-1,742 square feet and 11 three-bedroom, two-bath units ranging in size from 1,445-1,964 square feet; as well as 283 on-site residential parking stalls and 14,485 square feet of commercial space, and

WHEREAS the Director of Community and Economic Development has reviewed the proposed property tax exemption and recommends that a conditional



property tax exemption be awarded for the property located at 4851-4961 Main Street in the Point Ruston Mixed-Use Center, as more particularly described in the attached Exhibit "A"; Now, Therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

Section 1. That the City Council does hereby approve and authorize a conditional property tax exemption, for a period of eight years, to Point Ruston Baker Building, LLC, for the property located at 4851-4961 Main Street in the Point Ruston Mixed-Use Center, as more particularly described in the attached Exhibit "A."

Section 2. That the proper officers of the City are authorized to execute a Multi-Family Housing Eight-Year Limited Property Tax Exemption Agreement with Point Ruston Baker Building, LLC, said document to be substantially in the form of the proposed agreement on file in the office of the City Clerk.
