12 13	to fill the vacancy of Deputy Mayor for a one-year term through December 31, 2018;

1 A RESOLUTION related to the purchase of materials, supplies or equipment, and the furnishing of services; authorizing the execution of a contract 2 with Brown and Caldwell, in the amount of \$419,034, plus applicable sales tax, budgeted from the Wastewater Fund, for consultant 3 engineering services and an assessment of concrete and structural steel components at the Central Wastewater Treatment Plant and the North 4 End Wastewater Treatment Plant, pursuant to the Architectural and 5 Engineering Roster. 6 WHEREAS the City has complied with all applicable laws and processes 7 governing the acquisition of those supplies, and/or the procurement of those 8 services, inclusive of public works, as is shown by the attached Exhibit "A," 9 10 incorporated herein as though fully set forth, and 11 WHEREAS the Board of Contracts and Awards has concurred with the 12 recommendation for award as set forth in the attached Exhibit "A"; Now, 13 Therefore, 14 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA: 15 Section 1. That the Council of the City of Tacoma concurs with the 16 17 Board of Contracts and Awards to adopt the recommendation for award as set 18 forth in the attached Exhibit "A." 19 Section 2. 1 2	A RESOLUTION related to collective bargaining; authorizing the execution of a three-year Collective Bargaining Agreement between the City and District
3	Lodge #160 on behalf of Local Lodge #297 of the International Association of Machinists and Aerospace Workers, Yard Clerk Unit, effective retroactive
4	to January 1, 2017, through December 31, 2019.
5	WHEREAS the City has, for years, adopted the policy of collective
6	bargaining between the various labor organizations representing employees and
7	the administration, and
8	WHEREAS this resolution allows for the execution of a three-year Collective
9	Bargaining Agreement ("CBA") between the City and District Lodge #160 on behalf
10 11	of Local Lodge #297 of the International Association of Machinists and Aerospace
12	Workers, Yard Clerk Unit ("Union"), on behalf of the employees represented by
13	said Union, and
14	WHEREAS the bargaining unit consists of approximately five budgeted,
15	full-time equivalent ("FTE") positions assigned to Tacoma Public Utilities, Rail
16 17	Division, and
18	WHEREAS the CBA will provide for a wage increase effective retroactive to
19	September 18, 2017, to \$34.72 per hour; a wage increase effective retroactive to
20	January 1, 2018, to \$35.57, and an increase effective January 1, 2019, to \$36.47,
21	and

23	WHEREAS the agreement also provides for a one-time lump sum payment
24	of \$1,000 to each employee in the Yard Clerk classification; and in accordance
25	with the Western Metal Industry Pension Fund Rehabilitation Plan – Preferred

	Schedule, effective July 1 of 2018 and 2019, employees will forego an additional
1	amount of their wages toward a supplemental rate increase, and
2	WHEREAS other changes include the following: (1) the addition of a City
3 4	match to 457(b) deferred compensation contributions of Yard Clerks up to
5	3 percent; (2) a change from a reimbursement to an allowance for work boots, with
6	an increase to the annual amount of \$175 to \$300 per employee; and (3) provides
7	the employer with the ability to force the junior Yard Clerk to work in the event they
8	are unable to fill a vacancy, and
9 10	WHEREAS it appears in the best interests of the City that the CBA
11	negotiated by said Union and the City be approved; Now, Therefore,
12	BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:
13	That the proper officers of the City are hereby authorized to execute the
14	three-year Collective Bargaining Agreement between the City and District
15 16	Lodge #160 on behalf of Local Lodge #297 of the International Association of
17	Machinists and Aerospace Workers, Yard Clerk Unit, effective retroactive to
18	January 1, 2017, through December 31, 2019, said document to be substantially
19	in the form of the agreement on file in the office of the City Clerk.
