# **RESOLUTION NO. 40031**

A RESOLUTION relating to collective bargaining; authorizing the execution of a Letter of Agreement negotiated between the City of Tacoma and Tacoma Fire Fighters Union, Local 31.

WHEREAS the City has, for years, adopted the policy of collective bargaining between the various labor organizations representing employees and the administration, and

WHEREAS Resolution No. 39283, adopted October 6, 2015, authorized the execution of the 2015-2018 Collective Bargaining Agreement ("CBA") between the City of Tacoma and Tacoma Fire Fighters Union, Local 31 ("Union"), on behalf of the 361 employees represented by said Union, and

WHEREAS the City and Union have negotiated a Letter of Agreement ("LOA") to the CBA, extending the current CBA for two years, through December 31, 2020, and

WHEREAS the LOA provides for the following wage increases:

(1) retroactive to June 1, 2018, wages will increase by 4.0 percent; (2) effective

January 1, 2019, wages will increase by a minimum of 2.72 percent, plus any
adjustment needed based on a market review to maintain a second-place ranking
among comparable jurisdictions; and (3) effective January 1, 2020, wages will
increase by 4.0 percent, and

WHEREAS the LOA also includes language allowing employees time off to attend, as long as their absence does not reduce staffing levels established for their shift:

# SUBSTITUTE ORDINANCE NO. 28381

AN ORDINANCE related to the vacation of City right-of-way; vacating the north 10 feet of South 23rd Street, lying between the westerly margin of Jefferson Avenue and the easterly margin of Fawcett Avenue, to the City of Tacoma for use in an economic development project; and adopting the Hearing Examiner's Findings, Conclusions, and Recommendations related thereto.

WHEREAS all steps and proceedings required by law and by resolution of the City Council to vacate the portion of the right-of-way hereinafter described have been duly taken and performed; Now, Therefore,

#### BE IT ORDAINED BY THE CITY OF TACOMA:

Section 1. That the City Council hereby adopts the Hearing Examiner's Findings, Conclusions, and Recommendations as contained in the Hearing Examiner's Report and Recommendation to the City Council bearing File No. 124.1369 and dated August 26, 2016, which Report is on file in the office of the City Clerk.
