3	Avenue South.
4	WHEREAS, on July 27, 2016, the Community and Economic Development
5	Department ("CEDD") issued a Request for Developer Interest to build a mixed-
6	use development at 1210 Tacoma Avenue South, a City-owned parcel which was
7 8	declared surplus by the City, and
9	WHEREAS, pursuant to that process, HQC USA LLC ("HQC") was chosen
10	as the developer for the site, and
11	WHEREAS, on December 22, 2016, a Development Agreement was
12	entered into between the City and HQC and, since that time, has been amended
13 14	twice in order to accommodate the first multi-family investment from Vietnam in the
15	United States, and
16	WHEREAS, due to the complexity of the foreign financing, construction
17	stopped in July 2018, and
18	WHEREAS the proposed Third Amendment to the Development Agreement
19	outlines the steps necessary to restart the project in a way that better meets the
20 21	needs of the community, provides greater flexibility with the development plan, and
22	extends the project schedule, and
23	WHEREAS key amendments are as follows: (1) HQC must provide a fully
24	executed commitment letter from a lender or equity partner, demonstrating that
25	
26	100 percent of funding has been secured to complete the project, no later than

	April 30, 2019; (2) Increase the number of units from 150 to a minimum of 180;
1	(3) Due to project redesign, HQC shall submit for permit revisions by June 4, 2019;
2	(4) Construction shall recommence by September 3, 2019; and (5) HQC shall
3 4	complete construction and commence operating, having obtained a certificate of
5	occupancy, by December 31, 2020, which is 15 months later than anticipated, and
6	WHEREAS CEDD staff is recommending that the proposed amendment be
7	approved to allow HQC to complete development of the project; Now, Therefore,
8	BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:
9	That the proper officers of the City are hereby authorized to execute the
10 11	Third Amendment to the Development Agreement with HQC USA LLC, for the

RESOLUTION NO. 40317

1 A RESOLUTION relating to the multi-family property tax exemption program; authorizing an amendment to the Multi-Family Housing Eight-Year Limited 2 Property Tax Exemption Agreement with HQC USA LLC, for the development of 186 multi-family market-rate rental housing units to be 3 located at 1210 Tacoma Avenue South in the Downtown Regional Growth Center. 4 5 WHEREAS the City has, pursuant to chapter 84.14 of the Revised Code of 6 Washington, designated several Residential Target Areas for the allowance of a 7 limited property tax exemption for new multi-family residential housing, and 8 WHEREAS the City has, through Ordinance No. 25789, enacted a program 9 10 whereby property owners in Residential Target Areas may qualify for a Final 11 Certificate of Tax Exemption which certifies to the Pierce County 12 Assessor-Treasurer that the owner is eligible to receive a limited property tax 13 exemption, and 14 WHEREAS, pursuant to Resolution No. 39800, adopted on August 29, 2017, 15 16 HQC USA LLC executed a Twelve-Year Limited Property Tax Exemption 17 Agreement for the development of 166 multi-family market-rate affordable rental 18 units, and 19 WHEREAS HQC USA LLC now desires to amend the agreement to change 20 from a Twelve-Year Limited Property Tax Exemption Agreement to an Eight-Year 21 22 Limited Property Tax Exemption Agreement, and to revise the terms of the 23 proposed development, and 24 WHEREAS HQC USA LLC, is proposing to develop 186 market-rate rental 25 units to consist of 13 studio units, with an average size of 450-500 square feet and 26



renting for approximately \$1,200-\$1,400 per month; 143 one-bedroom, one-bath 1 units with an average size of 490-1150 square feet and renting for approximately 2 \$1,500-\$1,700 per month: 14 two-bedroom, one-bath units with an average size of 3 950 square feet and renting for approximately \$2,200 per month; and 4 16 two-bedroom, two-bath units with an average size of 1,090 square feet and 5 renting for approximately \$2,400 per month, as well as 174 on-site residential 6 7 parking stalls, and 8 WHEREAS the Director of Community and Economic Development has 9 reviewed the proposed property tax exemption and recommends that a conditional 10 property tax exemption be awarded for the property located at 1210 Tacoma 11 Avenue South in the Downtown Regional Growth Center Mixed-Use Center, as 12 13 more particularly described in the attached Exhibit "A"; Now, Therefore, 14 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA: 15 Section 1. That the City Council does hereby approve and authorize a 16 conditional property tax exemption, for a period of eight years, to HQC USA LLC, 17 18 for the property located at 1210 Tacoma Avenue South in the Downtown Regional 19 Growth Center, as more particularly described in the attached Exhibit "A." 20 Section 2. That the proper officers of the City are authorized to amend the 21 existing Multi-Family Housing Twelve-Year Limited Property Tax Exemption 22 23 24 25 26 -2-Res19-0413.doc-DEC/ae

A RESOLUTION relating to the City of Tacoma, Department of Public Utilities, 1 Light Division (d.b.a. "Tacoma Power"), Click! Network Unit; authorizing the 2 execution of a Retention Agreement and Severance Agreement between the City and non-represented employees of the Click! Network Unit. 3 WHEREAS the City and the Click! Network Unit (Click!") have negotiated a 4 5 Retention Agreement and Severance Agreement for non-represented employees, 6 and 7 WHEREAS the proposed Retention Agreement applies to employees who 8 have been deemed essential for the transition of Click! operations to a new 9 10 partner, and 11 WHEREAS the proposed Retention Agreement provides for the specific 12 definition and designation of essential employees who, upon completion of their 13 time deemed as essential by the Director of Utilities or until Click! ceases 14 operations as a City-owned entity, would be eligible for a one-time lump sum 15 16 payment of \$15,000 in compensation for their successful contribution under the 17 Retention Agreement, and 18 WHEREAS, in addition, during the time period an employee is deemed 19 essential under the terms of the Retention Agreement, the employee will receive 20 one eight-hour floating holiday every two months during the time they are 21 22 employed with Click!, with the first holiday to be awarded retroactive to April 1, 23 2019, and subsequent days awarded each two months thereafter, subject to 24 customary usage and cash out restrictions consistent with Tacoma Municipal 25 Code 1.12.200, and 26

1	A RESOLUTION relating to the homeless emergency; authorizing the execution
2	of an agreement with the Tacoma Rescue Mission in the amount of \$1,600,000, budgeted from the Capital Projects Fund, for the purpose of
3	supporting the Tacoma Rescue Mission's emergency shelter expansion of 50 beds, to reduce the number of individuals residing in unauthorized
4	encampments and areas unfit for human habitation.
5	WHEREAS there are currently 400 shelter beds available in the City for
6	single adults, families, youth, young adults, and survivors of domestic violence
7	experiencing homelessness, and
8	
9	WHEREAS the City's emergency shelters turn away 60-70 individuals and
10	families each night due to limited availability of bed space, and
11	WHEREAS, in May 2017, the City declared a state of emergency in
12	response to the growing number of people living in homeless encampments in
13	Tacoma, and
14	
15	WHEREAS, in order to address the emergency, a three-phase emergency
16	response plan was developed, with Phases I and II implemented immediately to
17	mitigate public health impacts of encampments and provide safe, hygienic,
18	temporary shelter for those residing in them, and
19 00	WHEREAS Phase III was intended to identify short-term transitional
20 21	housing, referred to as the "Readiness Site"; however, staff research determined
21	that a transitional housing option such as the Readiness Site was not a financially
23 24	feasible or sustainable option, and

WHEREAS staff is recommending the use of funding previously authorized 1 for development of a Readiness Site for shelter expansion at the Tacoma Rescue 2 Mission ("Rescue Mission"), and 3 WHEREAS the proposed expansion will transition an existing warehouse 4 and storage facility located at the current Rescue Mission site to a permanent 5 6 shelter, to provide temporary twenty-four hour shelter for adults, and 7 WHEREAS the total cost for the expansion project is \$2,650,000, to be 8 funded as follows: (1) the City of Tacoma, in the amount of \$1,600,000; (2) two 9 private donors, in the amount of \$600,000, conditioned upon securing City funding; 10 and (3) the Rescue Mission, in the amount of \$450,000, and 11 12 WHEREAS approval of the proposed allocation of the second part Real 13 Estate Excise Tax (REET 2) for this project by June 30, 2019, will constitute use of 14 those funds to address homelessness and thereby will allow City to utilize the 15 greater flexibility in REET 2 allocation afforded by recently enacted Engrossed 16 House Bill 1219, and 17 18 WHEREAS the proposed Agreement to convert expansion an existing 19 warehouse and storage facility located at the current Rescue Mission site to a 20 permanent shelter is a measure taken pursuant to, and intended to address in part, 21 the City's declared state of emergency regarding homelessness; Now, Therefore, 22 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA: 23 24 Section 1. That the foregoing Recitals are incorporated herein as the City 25 Council's legislative findings. 26
