RESOLUTION NO. 40579

A RESOLUTION amending Resolution No. 40570, relating to the Tideflats Interim Regulations public hearing, to change the public hearing date to Tuesday, May 5, 2020 upon completion of Regular Agenda Items, no earlier than 5:15 p.m.

WHEREAS on May 9, 2017, the City Council adopted Resolution

No. 39723, initiating a subarea planning process for the Port of Tacoma/Tideflats

("Tideflats") area, which additionally requested the Planning Commission

("Commission") to consider the need for interim regulations in the Tideflats area

while the subarea planning process is under way, and

WHEREAS the Commission determined the interim regulations were warranted, and forwarded its recommendation to the City Council for consideration on October 4, 2017, and

WHEREAS in support of these deliberations, the Commission conducted a public hearing at which 81 people testified, and reviewed over 200 written comments, and

WHEREAS, following its own public hearing with substantial community input and deliberation, the City Council adopted the interim regulations on November 21, 2017, by Amended Ordinance No. 28470, which includes the following elements:

- Category 1: Expanded public notification of heavy industrial use permits;
- Category 2: Temporary prohibition of new non-industrial uses in the Port of Tacoma Manufacturing and Industrial Center;

 Category 3: Temporary prohibition of new residential development along Marine View Drive and northeast Tacoma slopes; and

 Category 4: Temporary prohibition on certain types of new heavy industrial uses.

WHEREAS following another public hearing, which included substantial community input and deliberation, the City Council passed Ordinance No. 28542 on November 13, 2018, which extended the interim regulations for another six months, and

WHEREAS following another public hearing, which included substantial community input and deliberation, the City Council passed Ordinance No. 28583 on May 21, 2019, which extended the interim regulations for another six months, with an expiration date of December 2, 2019, and

WHEREAS following another public hearing, which included substantial community input and deliberation, the City Council passed Ordinance No. 28619 on November 12, 2019, which extended the interim regulations for another six months, with a current expiration date of May 2, 2020; Now, Therefore,



BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

Section 1. That Tuesday, May 5, 2020, upon completion of the Regular Agenda items, no earlier than 5:15 p.m., is hereby fixed as the time and date, for a public hearing to be held on the potential reauthorization and extension of the Tideflats Interim Regulations, in a manner and forum to be published on the City of Tacoma's website, and which is compliant with the Proclamation 20-28 issued by Governor Jay Inslee on March 24, 2020, which prohibits in-person meetings and temporarily suspends portions of the State Open Public Meetings Act.

Section 2. That the City Council finds that this Resolution is necessary, routine, and consistent with Governor Inslee's emergency proclamation issued March 24, 2020, suspending portions of the Open Public Meetings Act for 30 days.

RESOLUTION NO. 40580

A RESOLUTION relating to collective bargaining; authorizing the execution of a Letter of Agreement negotiated between the City of Tacoma and the International Brotherhood of Electrical Workers, Local 483, Tacoma Power Unit.

WHEREAS the City has, for years, adopted the policy of collective bargaining between the various labor organizations representing employees and the administration, and

WHEREAS Resolution No. 39935, adopted February 6, 2018, authorized the execution of the four-year Collective Bargaining Agreement ("CBA") between the City of Tacoma and the International Brotherhood of Electrical Workers, Local 483, Tacoma Power Unit ("Union"), on behalf of the employees represented by said Union, and

WHEREAS the City and Union have negotiated a Letter of Agreement ("LOA") to the CBA which provides for the following: (1) the creation of a new classification to be titled Electrician, Lead (CSC 5237), which will be classified, overtime category C, and have a one-step, hourly rate of \$45.88, set at ten percent above the current rate of pay of the Electrician (CSC 5236) classification; (2) the elimination of Step 1 of the pay scale of the current Heating/AC Maintenance Mechanic Supervisor (CSC 5145) classification, due to compression and for clarification; and (3) amendments to Article 9.1 of the collective bargaining agreement to clarify how temporary upgrades will be offered and how upgraded employees will be compensated, and

WHEREAS the LOA was considered and approved by the Public Utility Board at its special meeting of March 31, 2020, and
