1 A RESOLUTION related to collective bargaining; authorizing the execution of a four-year Collective Bargaining Agreement between the City, the Tacoma 2 Municipal Court, and the International Brotherhood of Electrical Workers, Local 483, Court Clerks Unit, consisting of 18 budgeted full-time equivalent 3 positions, effective retroactive to January 1, 2022, through December 31, 2025. 4 5 WHEREAS the City has, for years, adopted the policy of collective 6 bargaining between the various labor organizations representing employees and 7 the administration, and 8 WHEREAS this resolution allows for the execution of a four-year Collective 9 10 Bargaining Agreement ("CBA") between the City, the Tacoma Municipal Court, and 11 the International Brotherhood of Electrical Workers, Local 483, Court Clerks Unit 12 ("Union"), on behalf of the employees represented by said Union, and 13 WHEREAS the bargaining unit consists of approximately 18 budgeted. 14 full-time equivalent ("FTE") positions, and provides for wage increases in each year 15 16 of the agreement, and 17 WHEREAS the CBA will provide for a general wage increase and a market-18 based adjustment to the classification of Court Clerk, retroactive to January 1, 2022, 19 and 20 WHEREAS other changes include: (1) Adding a new classification of Court 21 22 Financial Clerk to the bargaining unit effective retroactive to January 1, 2022; 23 (2) Changing language in Article 2 – Union Recognition to reflect the legal 24 requirements of the Janus v. WHEREAS the City was not previously aware of the impact of this change in state law to its enforcement authority and the need to amend the TMC; Now, Therefore,

BE IT ORDAINED BY THE CITY OF TACOMA:
 Section 1. That the City Council hereby adopts the Recitals of this
 Ordinance as its formal legislative findings.

Section 2. That Chapter 8.105 of the Tacoma Municipal Code is hereby
 amended by repealing the previous adoption of Chapter 26.50 Revised Code of
 Washington ("RCW") and adopting by reference Chapter 7.105 RCW, as set forth
 in the attached Exhibit "A."

Section 3. That, based upon the facts and conclusions as specified
 herein, a public emergency exists, making this ordinance effective upon passage
 by an affirmative vote of a least six members of the City Council.

Section 4. If any section, subsection, sentence, clause, or phrase of this 16 ordinance is for any reason held to be invalid or unconstitutional by a decision of 17 18 any court of competent jurisdiction, such decision shall not affect the validity of the 19 remaining portions of this ordinance. The City Council hereby declares that it 20 would have passed this ordinance and each and every section, subsection, 21 sentence, clause, or phrase not declared invalid or unconstitutional without regard 22 to whether any portion of the ordinance would be subsequently declared invalid or 23 unconstitutional. 24

Section 5. That the City Clerk, in consultation with the City Attorney, is
 authorized to make necessary corrections to this ordinance, including, but not
