WHEREAS the Pierce County Auditor has requested that Danette Knowles fill the Council District No. 1 position, and Keoni Ho fill the Council District No. 2 position, with three-year terms to expire September 30, 2025, and

WHEREAS, pursuant to the City Charter Section 2.3, the persons named on Exhibit "A" have been selected by the Pierce County Auditor to serve on the CCES; Now, Therefore,
