Dear Mayor Woodards and Tacoma City Councilmembers,

In order to preserve the viability of the our region's natural and human environments for future generations and other forms of life, it is clear that not only must we strengthen the interim regulations to halt expansion of existing fossil-fuel industry in our Port, but we must also pause expansion of all fossil-fuel industry -- including in our Port -- to drastically suppress global CO2 emissions and stave off climate collapse.

In solidarity with other environmental and environmental justice organizations in the City of Tacoma, we acknowledge the following:

- 1. Our future economy cannot rely on fossil fuel if we want to maintain a life-sustaining environment. By allowing expansion of the existing fossil fuel industry in our Port, we are simply kicking the can down the road. As a City, we are failing to provide a safe and healthy community for current and future generations. This decision will fall on the wrong side of history.
- 2. Allowing existing companies to expand while limiting newcomers allows existing companies an unfair competitive advantage. Last time we were here reviewing these interim regulations, even industry representatives favored maintaining them. They've realized it works in their favor, appeasing some while risking minimal capital losses.

- 3. The Trump administration's dangerous environmental rollbacks, and its stimulus and recovery packages granted to the fossil fuel industry during this COVID-19 crisis, are an attempt to opportunistically prop up our dead-end fossil fuel industry. Our continued reliance on the artificially propped-up fossil fuel industry will lock Tacoma into dangerous and unstable industries. We need to support more stable industries today, to avoid future economic collapse.
- 4. This COVID-19 crisis is also an opportunity. With many families out of work and sheltered at home, we must truly reflect on which economic sectors, government services, and human experiences are "essential," and which aren't. With demand for fossil fuel at record lows, we can learn how to rebuild an economy that does not demand fossil fuels, and that builds systems that truly support the safety and health of our people. The Interim Regulations and Subarea Plan are critical tools to lead to a clean and equitable economic recovery.

As Ecosocialists, we demand that you:

- 1. Pause all fossil-fuel industry expansion in our Port.
- 2. Pause all construction projects in the Port that are currently opposed by the Puyallup Tribe of Indians until they can be meaningfully consulted and any outstanding lawsuits are resolved. We cannot continue to externalize the negative impacts of the fossil fuel industry onto the Indigenous people of the Tacoma area.
- 3. Disallow the residential use of city land within the Port. This means immediate closure of facilities that house people in the Port, including the Northwest Detention Center.
- a. When we agreed to limit residential use around the Port in the initial regulations, we acknowledged that it is not safe for people to live so close to dangerous industry. The people living at the NWDC deserve safety, just as the residents of Browns Point.
- 4. Include provisions that encourage non-fossil-fuel industrial use in the Port. There is a critical opportunity to create jobs and products that people need and don't destroy the environment.
- 5. Provide non-fossil fuel job retraining opportunities for all Port workers in existing fossil-fuel industries. These employers, reaping huge profits from fossil-fuels, can afford to help their workers who seek new opportunities in an inevitably changing economy.

Interim regulations serve to protect the public interest while we work on more permanent protections. Protecting the public isn't simply about pausing industries that we know are hurting us, it's also about preventing future harms that we know will manifest.

Workers in fossil fuel industries face huge job losses unless we start promoting meaningful job alternatives now. People living in and around the Port face devastating negative health impacts unless we stop pollution in the Port. And our global community faces extinction if we continue burning fossil fuels.

Inaction around fossil fuel will cause disproportionate suffering for working people, black and brown people, and vulnerable ecosystems. In a spirit of solidarity, we demand that you work to limit suffering among the poor and vulnerable, and that you work to assure that whatever suffering is required to get us all through this climate crisis is equitably shared by those in power.

My name is Marquis King Mason, I am an organizer with Citizens for a healthy bay.

I want to start off my testimony by thanking everyone who's here today. The weight of everything right now is palpable and showing up matters more than ever.

With this time of great duress, I think there is an even greater responsibility put on all of us who have the means to step up, to do so. The oil market is at its most volatile, <u>polluted communities are being hit the hardest by Covid-19</u>, and the impacts of the fossil fuel industry on our social, economic, and physical health are as clear as ever. We need stable, clean industries in the port that do not threaten our health.

After looking at the current facilities in the port like US. Oil and Targa, Citizens for a Healthy Bay has found out that with their current permits, we could see an increase of up to 1200 more oil carrying ships a year. The existing facilities not covered by the Interim Regulations could simply exercise their ability to use their permits to the fullest extent, which would put us at untold risk of accident like derailment or even explosion, like Oregon saw in Mosher back in 2016. When you combine that with the 2,000 more oil rail cars we've already seen since the regulations went into effect, it doesn't take an expert to see how this could end in disaster.

You can find this study CHB published attached with my written testimonial.

The ability for existing facilities to expand with no additional regulations is the elephant in the room, and we must change that. We cannot endure anymore risk, especially right now and in the near term uncertain future. With the Covid-19 epidemic bearing down on us, we cannot wait for the subarea plan to determine the future of the Tacoma Tideflats. The drain on government resources is sure to delay the Subarea planning process. City Council must use all the tools in its toolbox to protect us and help usher in a new era of green development.

Whether those tools are:

- Passing an amendment to limit expansion by 10% pending a conditional use permit
- Ordering the planning department and commission to look at creating permanent regulations until the subarea plan is completed
- Or using whatever other regulatory frameworks you can to protect Tacoma

We need action.

The city fought to be the first to step up in Washington and pass a climate emergency resolution, with the promise of addressing the environmental and climate degradation happening before our very eyes. It's time to follow that sentiment and finally strengthen the interim regulations.

RE: Six-month Renewal of Tideflats Interim Regulations

Dear Mayor Woodards and Tacoma City Council,

Thank you for providing the opportunity to comment on the six-month renewal of the Tideflats Interim Regulations (the Regulations).

Citizens for a Healthy Bay (CHB) is a 30-year-old organization whose mission is to represent and engage people in the cleanup, restoration, and protection of Commencement Bay, its surrounding waters and natural habitat. We are a 501(c)3 nonprofit providing practical, solutions-based environmental leadership in south Puget Sound. We work side-by-side with residents, businesses, and government to prevent and mitigate pollution and to make our community healthier and more vibrant.

CHB staff have spent hundreds of hours reviewing related data and policies, and discussing our view of the Regulations with City staff and Council. We know the renewal process for these regulations has been arduous, and we commend Mayor Woodards and City Council for staying present. Like you, we are concerned about the trajectory these regulations are seeming to take.

The Regulations were meant to set a baseline for industrial activity in the Tideflats – a snapshot in time of the regulated industries – so that there would be a consistent reference point to call back to for the drafting of the Tideflats Subarea Plan. Initially, it was thought that *interim* regulations would suffice, as it was presumed the Subarea Planning process would be complete within a year or two. However, it has become clear that that Subarea Planning process is taking much longer than anyone initially anticipated, and the Tideflats Interim Regulations are no longer an interim measure, but have functionally become a selective rolling moratorium.

Further, the outfall of the Covid-19 pandemic is draining the resources of the City, including furloughing staff and delaying contracts meant to supplement the City's pioneering Climate Emergency Resolution and Tideflats Subarea Plan. It seems imminent that the Subarea Plan will be further delayed, and the Tideflats Interim Regulations will continue to function as a rolling moratorium.

And during this interim period, we know that the Subarea Plan baseline has been moving. Our recent research found that the existing fossil fuel facilities in the Tideflats – that are

not subject to the Interim Regulations – have been moving greater volumes of oil through Tacoma since the Regulations first passed in 2017. For example, 67% more crude oil was delivered to Tacoma by rail in the fourth quarter of 2019 than the fourth quarter of 2016 - which was carried on 2,225 more rail cars. U.S. Oil & Refining Co. shipped out 176% more crude oil in Q4-2019 than they did in Q4-2016, and with their current permitting capacity, oil-shipping traffic in Commencement Bay could increase by up to 267 vessels per year. These are just two examples of existing facilities changing the baseline for the Subarea Plan under the current Interim Regulations.

While our Federal and State agencies are rolling back environmental protections and enforcement, we must rely more now than ever on our local government to protect our health and our environment. And because the baseline for the Subarea Plan keeps moving; and because the City's resources meant to manage the Interim Regulations are limited; and because the current Interim Regulations function as a rolling moratorium that gives preferential treatment to existing businesses, something needs to change.

We recommend the City use the resources already in its arsenal, namely, the Planning Commission and Planning Staff, to initiate this needed change. Due to the shifting conditions in which we find ourselves, it would be appropriate for Planning Commission to re-evaluate alternatives for establishing the baseline for the Subarea Plan. From their findings, permanent regulations that cover existing high-risk facilities in the Tideflats should be adopted, and would expire with the passage of the final Tideflats Subarea Plan. Lastly, the process to complete this evaluation and adoption of permanent regulations should be expedited, in order to lessen the burden on City resources.

- 1. Pause all fossil-fuel industry expansion in our Port.
- 2. Pause all construction projects in the Port that are currently opposed by the Puyallup Tribe of Indians until they can be meaningfully consulted and any outstanding lawsuits are resolved. We cannot continue to externalize the negative impacts of the fossil fuel industry onto the Indigenous people of the Tacoma area.
- 3. Disallow the residential use of city land within the Port. This means immediate closure of facilities that house people in the Port, including the Northwest Detention Center.
- a. When we agreed to limit residential use around the Port in the initial regulations, we acknowledged that it is not safe for people to live so close to dangerous industry. The people living at the NWDC deserve safety, just as the residents of Browns Point.
- 4. Include provisions that encourage non-fossil-fuel industrial use in the Port. There is a critical opportunity to create jobs and products that people need and don't destroy the environment.
- 5. Provide non-fossil fuel job retraining opportunities for all Port workers in existing fossil-fuel industries. These employers, reaping huge profits from fossil-fuels, can afford to help their workers who seek new opportunities in an inevitably changing economy.

Interim regulations serve to protect the public interest while we work on more permanent protections. Protecting the public isn't simply about pausing industries that we know are hurting us, it's also about preventing future harms that we know will manifest.

As environmental, faith, and community organizations working across the Northwest to protect the health and safety of our communities from the risks of oil transport, the undersigned 29 organizations urge the City of Tacoma to renew and strengthen the Tideflats Interim Regulations to include bans on expansions of existing high risk facilities.

The impacts of Tacoma City Council's decisions regarding Tacoma's land use and fossil fuel development extend far beyond the South Sound. Hazardous oil trains destined for U.S. Oil and SeaPort Sound Terminal not only pass through Tacoma and Pierce County, but through countless communities in the Northwest--including in Idaho, Spokane, and communities along the Columbia River Gorge--posing an acute risk of spills and explosions each step of the way. Indeed, the 2016 derailment of an oil train in Mosier, Oregon en route to Tacoma spilled 42,000 gallons of oil, ignited a toxic 14-hour fire of Bakken crude oil, and forced evacuations of the nearby community including prompting an early end to the school year due to disruptions to essential services.

Communities across Puget Sound also face increased oil spill risks from oil barges traveling weekly from Canada to U.S. Oil. With their recent purchase of U.S. Oil, Par Pacific has also already increased shipments of crude oil out from the facility with stated intentions to expand these operations, posing oil spill and vessel traffic threats to all of Puget Sound's shoreline communities.

Many of our organizations have been fighting for the better part of a decade against new crude oil terminals and dangerous oil transport through our communities. Expansions of crude oil storage and transloading in Tacoma would only undermine this work and further endanger our health and safety as our communities are used as corridors for oil transport. Like many of the proposals in our own communities, prospective expansions of fossil fuel facilities in Tacoma are rarely needed or intended to serve local demand or refined fuel needs. Dear Mayor Woodards and Tacoma City Councilmembers:

In order to preserve the viability of the our region's natural and human environments for future generations and other forms of life, it is clear that not only must we strengthen the interim regulations to halt expansion of existing fossil-fuel industry in our Port, but we must also pause expansion of all fossil-fuel industry -- including in our Port -- to drastically suppress global CO2 emissions and stave off climate collapse.

In solidarity with other environmental and environmental justice organizations in the City of Tacoma, we acknowledge the following:

- 1. Our future economy cannot rely on fossil fuel if we want to maintain a life-sustaining environment. By allowing expansion of the existing fossil fuel industry in our Port, we are simply kicking the can down the road. As a City, we are failing to provide a safe and healthy community for current and future generations. This decision will fall on the wrong side of history.
- 2. Allowing existing companies to expand while limiting newcomers allows existing companies an unfair competitive advantage. Last time we were here reviewing these interim regulations, even industry representatives favored maintaining them. They've realized it works in their favor, appearing some while risking minimal capital losses.
- 3. The Trump administration's dangerous environmental rollbacks, and its stimulus and recovery packages granted to the fossil fuel industry during this COVID-19 crisis, are an attempt to opportunistically prop up our dead-end fossil fuel industry. Our continued reliance on the artificially propped-up fossil fuel industry will lock Tacoma into dangerous and unstable industries. We need to support more stable industries today, to avoid future economic collapse.
- 4. This COVID-19 crisis is also an opportunity. With many families out of work and sheltered at home, we must truly reflect on which economic sectors, government services, and human experiences are "essential," and which aren't. With demand for fossil fuel at record lows, we can learn how to rebuild an economy that does not demand fossil fuels, and that builds systems that truly support the safety and health of our people. The Interim Regulations and Subarea Plan are critical tools to lead to a clean and equitable economic recovery.

As Ecosocialists, we demand that you:
Pause all fossil-fuel industry expansion in our Port.
2. Pause all construction projects in the Port that are currently opposed by the Puyallup Tribe of Indians until they can be meaningfully consulted and any outstanding lawsuits are resolved. We cannot continue to externalize the negative impacts of the fossil fuel industry onto the Indigenous people of the Tacoma area.
3. Disallow the residential use of city land within the Port. This means immediate closure of facilities that house people in the Port, including the Northwest Detention Center.
a. When we agreed to limit residential use around the Port in the initial regulations, we acknowledged that it is not safe for people to live so close to dangerous industry. The people living at the NWDC deserve safety, just as the residents of Browns Point.
4. Include provisions that encourage non-fossil-fuel industrial use in the Port. There is a critical opportunity to create jobs and products that people need and don't destroy the environment.
5. Provide non-fossil fuel job retraining opportunities for all Port workers in existing fossil-fuel industries. These employers, reaping huge profits from fossil-fuels, can afford to help their workers who seek new opportunities in an inevitably changing economy.
Interim regulations serve to protect the public interest while we work on more permanent protections. Protecting the public isn't simply about pausing industries that we know are hurting us, it's also about preventing future harms that we know will manifest.
Workers in fossil fuel industries face huge job losses unless we start promoting meaningful job alternatives now. People

Inaction around fossil fuel will cause disproportionate suffering for working people, black and brown people, and vulnerable ecosystems. In a spirit of solidarity, we demand that you work to limit suffering among the poor and vulnerable, and that you work to assure that whatever suffering is required to get us all through this climate crisis is equitably shared by those in power.

living in and around the Port face devastating negative health impacts unless we stop pollution in the Port. And our global

community faces extinction if we continue burning fossil fuels.

Good afternoon. My name is Rev. Nancy Ferree-Clark. I am a recently retired United Methodist pastor, a proud resident of Tacoma, and a member of Earth Ministry.

You may know that we recently celebrated the 50th anniversary of Earth Day. Marking that important date brought back memories for me of the first Earth Day during my junior year in high school when I and my classmates were dismayed to learn that our planet was in serious trouble due to human intervention. Dear Madame Mayor Woodards and Councilmembers:

Thank you for accepting this letter on behalf of the Port of Tacoma regarding the proposed extension of the Tideflats Interim Regulations. Consistent with previous correspondence and testimony, the Port of Tacoma position remains unchanged; **interim regulations are unnecessary and may result in the negative unforeseen consequences of decisions made without time for proper vetting**. Additionally, as our attorney has previously pointed out, the process for adoption and content of the interim regulations for the Port Container Element of the City's Comprehensive Plan are likely legally flawed.

We acknowledge also that the City's current review of these interim regulations comes at a time when governments, communities, business owners, employees and employers are facing the unprecedented challenge of coping with the COVID-19 threat. Our state's governor has issued no less than 51 Emergency Proclamations in response.¹ It is a time of immense upheaval and uncertainty. The City, like the Port and other governments, is valiantly working in the face of these challenges to maintain even just the status quo of everyday business. Layered on top of that is the priority of keeping people safe and well. This is simply not the time to increase the strain on any element of the community through distraction of potential changes to the interim regulations. The City has characterized the Interim Regulations as a "pause". We ask that if the City Council deems the pause is still necessary, that the six-month extension result in regulations AS-IS without any additional use or permitting restrictions.

The Port believes that decisions on permanent Tideflats zoning and land use deserves a meaningful and comprehensive approach that is currently ongoing as part of the Tideflats Subarea Plan. Any changes to the permanent regulations must be consistent with the Growth Management Act – including the Container Port Element, the final Tideflats Subarea Plan, and the State Environmental Policy Act (SEPA). Permanent adoption of the regulations before the final approval of the Subarea Plan would not be consistent with the intent of the collaborative process required in RCW.36.70A.085.

¹ The City has issued its own emergency announcements. City facilities including administrative offices at the Tacoma Municipal Building complex (747 Market St. and 733 Market St.) are closed to the public beginning at 7:30 AM on March 18, until further notice. And, Pursuant to the City's state of emergency proclamation, Tacoma City Council has set the maximum occupancy of Council Chambers, not including Council and staff, at 10. Although written comment is available, this time of depressed public engagement further support that, if not repealed, no change be made to the Interim regulations.

The Port of Tacoma is a countywide organization formed, and continues to operate, with the purpose of job creation, environmental stewardship, and driving economic vitality. We endeavor to meet this purpose in parallel with the protection of natural resources and spreading economic impact and opportunity throughout the region. To continue this endeavor, it is imperative that our maritime, manufacturing, and industrial lands are protected from encroachment, and that a broad spectrum of industrial uses are allowed in the Tideflats.

Dear City Council Members,

My name is Meghan Mason, a realtor with John L Scott Puyallup, and I am writing on behalf of my client, Christine Ramsdell. She is the owner of a 5 acre parcel that has fallen under the moratorium for development as a result of these regulations. It is parcel # 0321254009 and has housing developments to the north, tribal housing to the south, and approved residential development to the east that has not yet broken ground. To the west there is nothing but critical area between the parcel and Norpoint Way NE. It is my understanding that my client's parcel has been impacted by the Tideflats Interim Regulations due to the proximity to the Port of Tacoma and that developing more than one dwelling has been prohibited due to the increasing complaints from residents that have issue with Port activity. At most, if this parcel were to be released from the moratorium, there would be 2 or 3 "rim lots" that would have a view of/exposure to the Port. There is a significant buffer zone between these lots and the Port caused by the critical area that exists on the slope both on the property and below it that cannot be developed. In Chapter 13.04 it states, "Land to be subdivided shall be of such character that it can be used safely for building purposes without danger to health or peril from fire, flood, or other menace, and land shall not be subdivided until adequate public facilities and improvements exist or proper provision has been made for drainage, water, sewerage, and capital improvements such as schools, parks, recreation facilities, and active transportation facilities." This lot already has all utilities present, sewer, water, and power and has no higher safety risk than any of the other developments that surround it. My client has been trying to sell this property for four years and these regulations have severely impacted the salability of the land. The location of this property makes any use other than residential illogical, but its value has been massively undercut by the inability to plat it. And yet, since my client came into possession of this property in 2015, the tax assessed value has more than doubled from \$148,900 in 2015 to \$305,900 in 2020. She is a senior citizen who is unable to work, and is saddled with a property that will not sell and is paying taxes at a rate that in my professional opinion is not justified by the limitations set to her land. The extension of regulations would keep landowners who wish to sell in a state of limbo as future buyers cannot determine how the land's use will be impacted in the future. In Chapter 13.06 it states,"As a condition of residential development, developers shall record a notice on title prior to initial sale which attests that the property is within proximity of an S-10, M-1, M-2, or PMI district in which industrial activities including but not limited to metal recycling, chemical storage and manufacturing, and container terminal facilities, are operating and will continue to operate and expand in the future. The distance of the unit from the nearest industrial zoning district shall be recorded." In regards to my client's lot, I believe the application of this condition is more than adequate in development beyond one-dwelling. My client and I implore the City Council to not extend the Tideflats Interim Regulations, or to at least allow for the release of her parcel from the development moratorium. It has caused her great hardship. Thank you for taking our comments into consideration.

On behalf of US Oil and Refining Co. ("US Oil"), I would like to thank you for this opportunity to comment on the most recent contemplation of interim land use regulations for the Tacoma TideFlats.

Headquartered on Commencement Bay since the 1950s, it is not by coincidence that US Oil's products are among the cleanest fuels on the market. In the shadow of Mt. Rainier and on the shores of Puget Sound, we are fundamentally shaped by who and where we are. Recently purchased by Par Pacific Holdings, US Oil nonetheless remains rooted in the community where we operate, alongside the people who are our employees and partners, and together we recognize and respect the imperative of protecting the environment where we also live and work.

Our engagement on the process regarding the health, safety and future of the TideFlats is one we take seriously. We continue to recognize the privilege of doing business here, and we understand and respect the values of our neighbors when it comes to the environment and health and safety of our workers and surrounding communities. That is why we believe the current six-month regulatory review of these programs is not aligned with achieving the community's goals of enhanced environmental, health or economic benefits through this program.

In addition, COVID-19 has changed the landscape around all of us in ways that are visible and knowable today, and in ways that are yet to be seen. As a community and in society at large, we are navigating unchartered waters. It is through this lens that we encourage a clear-eyed look at the impacts of this ongoing regulatory process and respectfully request that no additional requirements are imposed at this time. While not every business or every industry has been authorized to keep operating, US Oil is hard at work - focused on doing our part to balance the realities of the pandemic with the stability we can provide to our team, our customers and the public. The privilege and challenge of operating during this pandemic are a balancing act. Economic uncertainty and loss of demand have a heavy impact. We have taken on small projects such as repurposing tankage to ensure we can balance crude supply with production to avoid shutting down and furloughing our team. Increased regulation would impact our ability to preserve jobs at US Oil and those we create in the region. For us, being "essential" carries deep responsibility to maintain and strengthen our economic contributions to local and state government, to support our employees, and to continue to deliver products on which the public and our customers rely.

- Reliable Access to Fuel and Energy: the uncertainty caused by a global pandemic highlights the unflinching nature of the men and women of the oil and gas industry. From operators and mechanics to engineers and scientists, the team at US Oil has been focused on ensuring our customers, and their customers, continue to get the products they rely on fuel to keep the lights on, supply chains moving, and emergency crews and local military personnel powered up and ready to go.
- Engaged and Committed to Regulations: No part of our industry resists legislation or regulation that effectively and efficiently protects people and the environment. And our approach to the onset of COVID-19 and its implications only serves to reiterate our commitments. The industry has been tracking and adhering to early direction from Governor Inslee's office, aligning our operational norms with enhanced measures to protect our employees, public health and safety. On a national level, there has been some reporting that federal regulators were "relaxing" environmental rules at the expense of environmental protection. I would like to take this opportunity to make very clear that we do not, and will not, relax our commitment to comply with existing federal, state and local environmental regulations. Our values when it comes to the environment are unchanged, as are our commitments to this community. US Oil is closely monitoring direction from local and state government leadership we are proud to do our part as a company and as a community partner here in Tacoma.
- Ongoing Innovation for Cleaner Energy Sources: US Oil's regular engagement on the interim regulatory process on the Tacoma TideFlats should not be misconstrued as resistance to cleaner energy sources or innovation that helps drive a transition from traditional fossil fuels. In fact, it is regulatory uncertainty, not a lack of desire to evolve, that undermines progress toward more sustainable energy sources. Our company has a long history of reducing our environmental impact ahead of regulation, while producing the cleanest fuels on the market. US Oil invested to produce Ultra- Low Sulphur Diesel (ULSD) years ahead of the EPA mandate and has produced Tier III gasoline (national vehicle emissions and fuel standards that came into effect in 2017) for more than 20 years. More recently, US Oil shifted production of high sulfur fuel oil into asphalt, significantly reducing emissions ahead of IMO 2020.

Today US Oil further recognizes that we must anticipate and adapt to the increasing demand for renewable transportation fuels. Since 2015, US Oil has invested in onsite facility emission reduction projects that achieved a 24.7 percent reduction in US Oil's annual GHG emissions. We have already achieved the lowest carbon intensity among the five Washington refineries by a significant margin. We are currently investing in the Ethanol Next Gen Fuels project which will reduce global CO2 emissions equivalent to taking 65,000 cars off the road.

Yet, investment in capital projects needed to further reduce emissions, improve reliability of operations, and make the transition to lower carbon intensity is stymied by local regulations

that focus on the entirety of a global challenge and fail to see the small, progressive steps taken in our own backyard.

• The Home Team: US Oil is a small refiner, 1 yet it has become a market leader in the production and supply of high-quality motor and aviation fuels. These products primarily serve the needs of our community - 86% of US Oil products are sold and used in the local south Puget Sound market. By comparison, refineries near Bellingham send in excess of 50 percent of their production out of Washington State. New restrictions on US Oil production curtail innovations we pursue for greener fuels and undercut the environmental, economic and supply benefits of our community-focused refinery. Further, it is important to consider the unintended consequences of local versus state-wide or national requirements. When more stringent local requirements are adopted, it creates an unintended benefit to production of fuels outside of the region. This not only reduces the environmental benefits sought by the local requirements, but also reduces the economic benefits of local refining.

Today, the reliability of the energy sources that fuel our lives is a critical underpinning of crisis response and important to shore up public confidence as we seek certainty during this pandemic. Our hope is that in the months ahead, our contributions to the economy and as "essential" operators helps inform and establish stable future regulations. The ability to invest and innovate to pursue biorenewable energy sources that results in a more balanced energy mix is one we believe can help get beyond an impasse of ideals. Our ability to do so is significantly hampered by continued uncertainty in requirements. We look forward to collaborating with you and all stakeholders in this community to work toward these solutions.

Mayor Woodards and Tacoma City Councilmembers,

Thank you for accepting this letter on behalf of the International Longshore and Warehouse Union Local 23 regarding the proposed extension of the Tideflats Interim Regulations. Consistent with previous testimony, ILWU Local 23 remains unchanged; interim regulations are unnecessary and may result in the negative unforeseen consequences of decisions being made without time for proper vetting.

We acknowledge also that the City's current review of these interim regulations comes at a time when governments, communities, business owners, employees and employers are facing the unprecedented challenge of coping with the COVID-19 threat. It is a time of immense upheaval and uncertainty. The City, just as is ILWU Local 23 and other port workers, is valiantly working in the face of these challenges. Layered on top of that is the priority of keeping people safe and well. This is simply not the time to increase the strain on any element of the community through the distraction of changes to the Interim Regulations. The City has characterized the Interim Regulations as a "pause". ILWU Local 23 urges that now, more than ever, that pause, if not lifted, be left as is.

ILWU Local 23 believes that decisions on permanent Tideflats zoning and land use deserves a thoughtful and comprehensive approach that is currently ongoing as part of the Tideflats Subarea Plan. Permanent adoption of regulations before the final approval of the Subarea Plan would not be consistent with the intent of the collaborative process required n RCW.36.70A.085.

We appreciate your situation in having to deal with the state law requirement for six-month review of the Interim Regulations, but urge that this recurring process not be used to artificially truncate the meaningful Subarea Planning Actions. We ask that if the City Council deems Interim Regulations necessary, we request that the six-month extension result in regulations AS-IS without any additional us or permitting restrictions.

My name is William Golding, and I am a resident of Tacoma's Stadium District overlooking the Port of Tacoma. I am thankful to have the opportunity to provide public comment from these ancestral lands of the Puyallup Tribe of Indians and the 1854 Medicine Creek Treaty that provided all non-indigenous Americans the ability to live here with these lands, waters, airs, and non-human relatives.

I am providing public comment in response to tonight's public comment period related to the upcoming vote on Ordinance 20-0332 regarding the extension of the Tideflats Interim Regulations. I am in support of passing this ordinance to extend the interim regulations for the tideflats of Tacoma. I advocate further that the City of Tacoma move forward to pass an ordinance that permanently prohibits any new fossil fuel infrastructure developments in the Tideflats subarea as well as limits the expansion of all existing fossil fuel infrastructure in this area. I believe the passage of such an ordinance is necessary for the City to uphold its 2019 Climate Emergency Declaration (Resolution No. 40509) intentions to mitigate the impacts of our local to global current and future climate crisis that are articulated in the "Tacoma Climate Change Resilience Study" (2016).

The passage of such an ordinance to permanently prohibit the future of fossil fuel infrastructure in the Tideflats subarea is necessary for the City of Tacoma to uphold the nation-to-nation relationship with the Puyallup Tribe of Indians and the various rights detailed in the 1854 Medicine Creek Treaty. The Puyallup Tribe of Indians has clearly expressed their desire for a future that is free of fossil fuel infrastructure development in the Tideflats subarea (Link: http://news.puyalluptribe-nsn.gov/say-no-to-tacoma-lng/) as well as articulated in their own Declaration of Climate Emergency (Resolution No. 101219) (Link: http://news.puyalluptribe-nsn.gov/wp-content/uploads/2019/12/Signed-Resolution_Climate-Emergency.pdf).

As a concerned Tacoma resident, I implore my elected City officials to pass Ordinance 20-0332 and take their actions even further to meet current and future generation's needs for bold and decisive climate action by pivoting away from the past history of fossil fuel infrastructure in the Tideflats subarea and moving our shared home towards a more sustainable and healthy path forward into a dynamic future.
