As a resident of District 2 I am writing to support funding for sidewalk improvements across the city, but in particular in the South Tacoma area. There are numerous blocks that do not have sidewalks and ADA curb cuts are only as good as the sidewalks. While I am Vice Chair of the Tacoma Area Commission on Disabilities these comments are my own. The sidewalks are badly in need of repair and replacement in the South End. I would encourage the infrastructure funding from the federal government to be prioritized for sidewalks especially in the South Tacoma region of the city. Ms. Suzzanne Skaar (former Human Rights Commissioner) sent an email to Lucas Smiraldo with concerns about this and referenced communication from Public Works ADA Coordinator Gail Himes and the Commission on Disabilities Chair has shared similar concerns. As it appears Ms. Skaar noted concerns about the need as the South Tacoma area has historically been redlined for needed improvements such as the sidewalks. Ms. Skaar's problem areas around her neighborhood will be identified by the City as they have a meeting in her neighborhood scheduled as her and her coparent both tripped and Ms. Skaar's knee was injured with bruising and bleeding. This is concerning also as it is near a public school.

Again, I call upon federal funds related to infrastructure be utlized to improve sidewalks in the South Tacoma area.





I am submitting the following for public comment. I realize due to timing these may not be included in today's meeting; please include them in next week's meeting if that is the case. Thanks.

I'm writing to you with an urgent public safety and public health concern occurring in District 3, and more generally along the 6th Ave corridor between State St and Pine St.

There has been a recent and significant increase in open drug use, dumping/littering from people occupying their vehicles, and unsanitary conditions on the streets caused by public urination and the dumping of human waste on the street and sidewalk areas.

Many residents and business owners on the 6th Ave corridor are concerned about these conditions.

There was a growing encampment of people living in their vehicles and participating in open drug use and dumping trash for nearly 4 weeks, which was only cleared recently after significant neighborhood outcry. Recently my family has started to feel unsafe walking around our neighborhood at certain times, and last week my wife was threatened by someone shooting up in front of our house when she told them to leave, with our children in the yard. This is a significant change from our vibrant and friendly neighborhood culture.

The neighbors have dozens of 311 reports over the last few weeks, called the non-emergency line, and even 911 in several cases when there was threatening behavior and indecent acts occurring. However, the police have indicated these cars can park for 7 days, and have generally not been helpful in helping us solve this problem.

I'm asking you to help us engage on this problem, and specifically request the police enforce the existing law that prohibits the car camping outlines in *TMC 11.05.231 Human habitation of vehicles*. This section states, in part:

It is unlawful for any vehicle to be used for human habitation purposes for a period exceeding **72 hours** on a public street or public right-of-way anywhere in the City of Tacoma, unless a permit has been issued in accordance with subsections D and E herein. It shall be unlawful for a vehicle to be moved **any distance less than one mile** from the position it occupied at the start of the 72-hour period in order to avoid the time limit regulation of this section.

Additionally, I'm asking you to direct both public safety and public health resources to the 6th Ave corridor to provide supportive services for people willing to accept them, interdict the drug sales that occur in plain view on the 6th Ave corridor (and lead to people using in the surrounding blocks), and help support a safe and vibrant neighborhood for people, families, and businesses.
