Dear Mayor Woodards and all Tacoma City Council Members.

I am responding to the letter written by Mary Robnett and signed by numerous Mayors. First, I would like to offer some facts, then I will responding directly to issues raised in the letter. I am so pleased that you all have not yet signed this panic-driven letter. I imagine there is a lot of pressure to do so.

Important facts:

There are over 2 million people in our nation's prisons and jails— A 500% increase over the last 40 years. Changes in sentencing law and policy, **not changes in crime rates**, explains most of this increase. This has created an incredible fiscal burden on states, despite increasing evidence that large-scale incarceration is not an effective means of achieving public safety. We have created a massive, overcrowded incarceration “world” and, still, we have public safety challenges.

For perspective, not only does the U.S. have the highest incarceration rate in the world; every single U.S. state incarcerates more people per capita than virtually any independent democracy on earth. We have a history of responding to crime by imprisoning more and more people, pulling the felony card whenever possible, and meting out longer and longer sentences. Of course, people of color are targeted the most.

Street crime costs our country approximately 16 billion dollars/year. White collar crime costs us **25 times that**—approximately 400 billion dollars per year. Maybe redirect our law enforcement to that group of criminals...

I am struck by how much anxiety underlies this letter. Thoughtful decisions are rarely made when fear is the motivator. For example, suggesting that we again allow Law Enforcement Pursuits. My goodness, what a reckless idea. Pursuits can easily become a public safety issue. Too many people have been shot in the back being

pursued by police. Too many bystanders injured by vehicle pursuits. This is not what our police should be doing.

Another example is the suggestion to make drug possession a felony again, without proof of intent to distribute. Really? The reasoning given is that allegedly law enforcement is “prohibited” from booking a suspect in jail, even when drug possession is a misdemeanor. **That simply is not true.** Right In this letter it says that a suspect can be booked and prosecuted after a suspect has been previously detained twice and referred to social services. Makes sense. The third time this suspect is picked up he/she can be booked and prosecuted. However, according to this letter this doesn’t happen because “there is no statewide system for tracking these referrals”. Well, for goodness sake fix that! Ms. Robnett would rather criminalize simple drug possession than fix a system issue? Not acceptable.

Clearly, we do not need to make drug possession a felony or reinstate police pursuits to book and prosecute drug offenders. I do agree that coerced substance abuse treatment can be effective and a viable option for repeat offenders. Pierce County has had success with therapeutic courts.

The last thing we need is to act on the current level of anxiety and go backwards in our policing efforts, hunting down suspected criminals and slapping them with a felony. We all know the devastation a felony charge creates for a suspect and his/her family. Sort of reminds me of President Bush’s rush to start a war in Iraq in response to 911. We know how well that worked out!

I implore our Mayor and City Council to not be tempted to go for the scare-driven suggestions. We are better than that, and more creative.

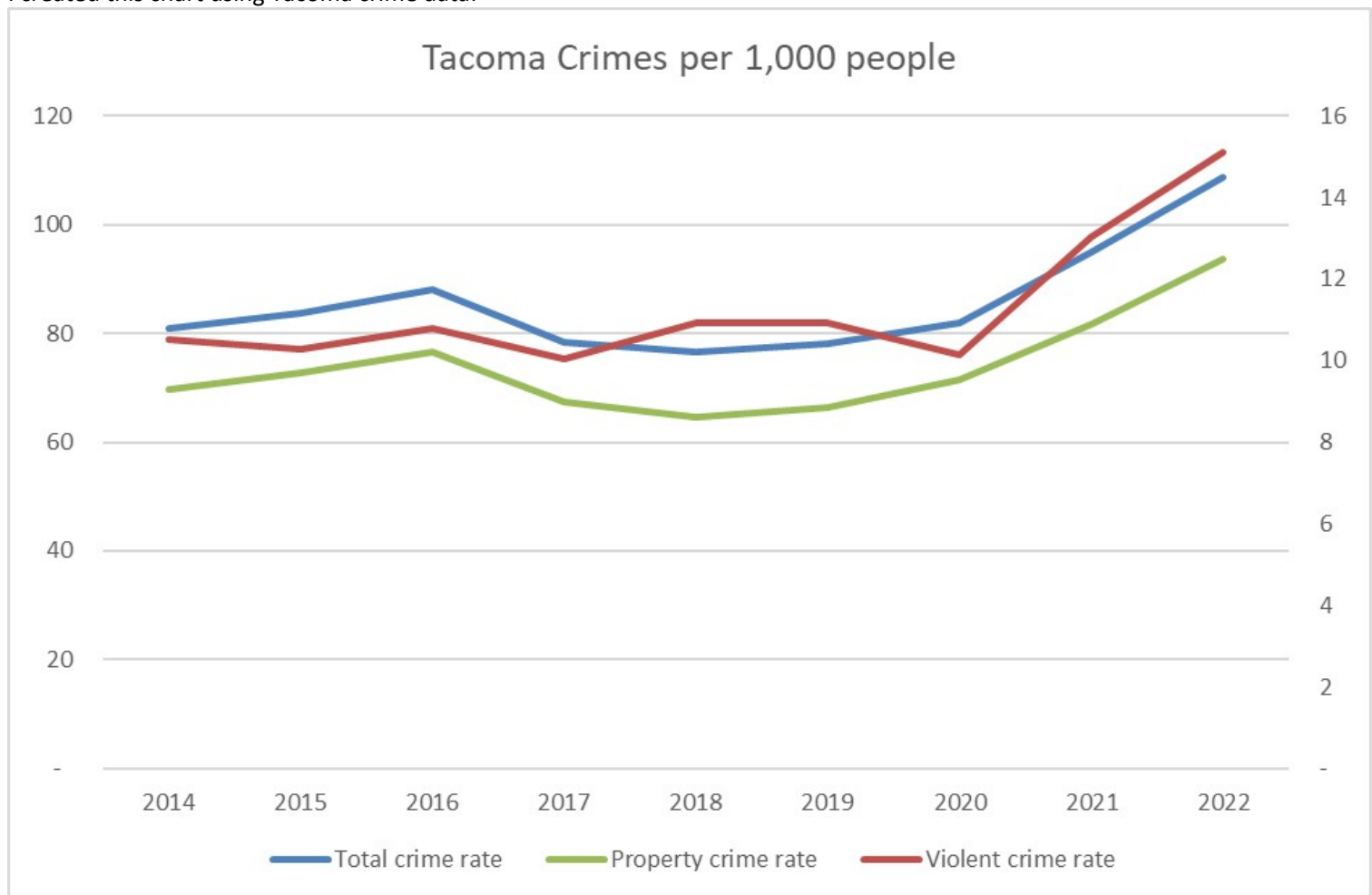

I was sent the 7 point statement below and agree with it 100%.

In my family I have 3 recovered alcoholics. I love each of them and feel blessed every day that they are alive, sober, and not in prison. Each of them got to very dark places in their lives before they were ready and able to do the incredibly hard work of getting sober. Alcoholics Anonymous refers to this as hitting "rock bottom"; a place where the pain your addiction causes you is large enough to drive you to get sober. We thought drug decriminalization would help make the lives of people struggling with addiction easier, but I believe we have made it harder because we have ended up enabling their addictions. The pleading of family, friends, and government officials is not enough for many addicts, they also need the fear of facing jail or prison time. Every day they remain in addiction is a day they may die of an overdose, a day they are not really there for their loved ones, a day lost out of their lives. Please support our prosecutor, give her the tools she needs to help these people reclaim their lives!

If the plight of people with addiction does not persuade you, surely 2022's **50%** increase in violent crime rate and **30%** increase in property crime rate vs 2020 is enough reason to act?

Carbines and pistols blazing, the 3rd Colorado Cavalry drives frantic Cheyennes from their village at Sand Creek, Colorado, on November 29, 1864, heedless of an American and a white flag the Indians had raised in a gesture of friendship. Six hours

later, the entire length of the creek bed for which the camp was named was littered with bodies. "All sexes and ages were killed," wrote a witness to the carnage, "women and children and warriors, all ages from one week to 80 years."
