I hear what you are saying. If you read both bills, SB 5467 and 5536, they both require drug treatment. One of the bill allows the individual to be convicted from the point of arrest. The other bill, SB5536, allows the person to put off jail time if they complete drug treatment. If they do not complete drug treatment, which I believe to be therapeutic court with all of the conditions included by the judge, they will then be put in jail. The lowest possible sentence is 90 days, the same as the first bill, SB5467, or up to 364 days in jail. I support this because if making drug a felony worked to rid of our drug problem, it should be gone by now because we have been doing that for over 40 years.

I can't answer questions regarding Pierce County and why they have let people out of jail. I can tell you that we at the city had to follow the Blake decision which meant we had to let people go who were not willing to take drug treatment. It was just voluntary. Both of the bills above require drug treatment.

I appreciate your concerns and hope you will reach out with other questions.

Dear Honorable Mayor Woodard and City Councilmembers,

We write to ask that the Council take a public stand on Washington's drug possession laws and on police pursuits. It is not enough that you direct Tacoma's lobbyist to advocate for your priorities. When the Mayor declined to sign the County Prosecutor's letter a very public message was sent that Tacoma disagreed with that letter. The city now must fix that. Please vote on January 31st to make a public statement on these important issues. The citizens of Tacoma need you to take concrete action to address the drug crisis that is taking so many lives. And we need you to speak clearly on police pursuits. Tacoma is one of the 3 largest cities in the State. Our voice matters. Please use that voice to influence Olympia to address the crime wave we are experiencing.

We ask that the City Council make a public statement addressing both drug possession and police pursuits. That statement must do the following:

- Call for our state delegation to introduce legislation returning drug possession to a
  felony offense. With a felony offense, we would have an effective legal structure in
  place immediately to fight the drug crisis which is not the case if the offense is merely
  a misdemeanor. That is based on the following facts:
  - Pierce county jails will book felony offenders. They do not currently book for nonviolent misdemeanors.
  - Pierce County has a well-funded and well-established therapeutic court system that could immediately begin offering help. In contrast, our municipal court relies on a grant to operate.
  - Pierce County has the capacity to address the influx of diversions to therapeutic courts. In contrast, our municipal court already has a large backlog.
- Call for all criminal offenses to be automatically vacated when the defendant successfully completes the court mandated treatment.
- Demand an end to the current "2 referrals" scheme so that the law can be enforced and that those suffering from addiction can begin to get the help they need.
- Call for the law to be enacted as an emergency measure so that it can take effect immediately.
- Call for changes to the Growth Management Act provisions to ensure that local governments have a say on where treatment facilities are located.
- And, importantly, it must call for police pursuits to be allowed on "reasonable suspicion" standard to create a credible threat that police could pursue those who break the law.

If the Council cannot support a felony charge, then your public letter to the state delegation must call for a "gross misdemeanor" and must demand significant state funding to equip our municipal court and therapeutic court with the staffing and resources to fully implement this law. In addition, the City must commit to making our therapeutic court system robust, and immediately contract with a jail that will book those who are arrested on misdemeanors since the Pierce County jail does not.



Both violent and property crime in Tacoma continues to rise despite real efforts to get crime under control. One clear root cause of crime is addiction and the drug trade. We must put teeth back into the law to address this. Not in an effort to, "lock people up" as suggested by CM Blocker on the 24th, but because the threat of criminal charges and time in prison is the leverage needed to get people into treatment. How many more people must die from overdoses due to fentanyl, meth and other illegal drugs before we decide to take concrete action?

Now is the time. A public statement of Tacoma's position is critical to ensuring that all our legislators hear clearly what our city demands to address the drug crisis through which we are living.
