## **Director's Report**

Director Hayward announced that the Charter Review Committee is in the process of updating the Tacoma City Charter. They welcome feedback and input from the community.

The Human Services Commission is considering applications for the Emergency Solutions Grant.

The HRC will present at the Public Safety, Human Services and Education Committee (PSHSE) on Thursday, March 27, 2014 at 4:30 p.m. in TMB 248. This will be an opportunity to highlight accomplishments for 2013 and engage PSHSE in discussion about the HRC's 2014 work plan.

Last summer, the City of Tacoma worked with Tacoma Public Schools, Reach Center and Work Force Central in a pilot program to help students who were behind in credit retention to graduate on time. This year, the City of Tacoma wants to expand the program and is approaching local businesses and organizations as potential partners.

The City Council will hold their annual planning session on Friday, February 21, 2014 and talk about their priorities for the year.

The City Council is requesting proposals to initiate the strategic planning process to create community priorities for the 2015-2016 budget process.

The Human Services Commission is in the process of updating their strategic plan.

Councilmember Woodard requested that the City of Tacoma present a Women History's celebration in March.

The NCS Department's Code Enforcement and Compliance section is currently conducting a citywide survey to educate businesses and communities about property improvement opportunities and obligations.
