Old Business

Investment Update

Tim Allen reported on public defined benefit plan returns and asset allocation as well as survey results conducted by MFS on asset mix and risk levels and quartile performance results.

Tim provided an update on the Eaton Vance funding of the new bank loan investment.

Earlier in November, Tim met with Parametric to discuss their approach to implementing Environmental, Social and Governance (ESG) strategies in public equity assignments in a way that helps mitigate the volatility that may result from divestment of some items.

CEM Benchmarking Review

The Board was provided with a complete report of 2015 Investment Benchmarking Analysis for TERS by CEM Benchmarking. For the existing asset allocation, TERS was rated as adding slightly more than expected in value added with a lower than expected cost.

New Business

Wilshire Presentation

The Retirement Board and Investment Advisory Committee received the Executive Summary – 3rd Ouarter 2016 from Wilshire Associates in hard copy.

Andrew Junkin addressed the possible effect on the markets of the recent result of the U.S. presidential election.

Felicia Bennett presented the Economic Overview and Executive Summary of Performance, including a review of the TERS plan asset allocation and investment performance for the quarter ended September 30, 2016.

The Tacoma Employees' Retirement System's rates of return were reported as follows: 2.98% for the Third Quarter, 11.42% for the one-year period, 7.24% for the three-year period, 10.53% for the five-year period, and 5.72% for the ten-year period ended September 30, 2016.

The Executive Summary of Performance for the period ending September 30, 2016 serves as an addendum to the minutes.

Andrew Junkin presented Wilshire's whitepaper "SMART BETA: the Space between Alpha and Beta". He provided an overview of applying smart Beta strategies to equity portfolios in a low return environment.
