Investment Update

Tim also reviewed trends in private equity-style infrastructure deals, with substantial new money flowing toward this area.

Discussion ensued revisiting the asset allocation topic of investing in TIPS versus Long U.S. Treasuries. Upon motion by Kim Moore, seconded by Tadd Wille, the Board directed TERS staff to enter into negotiations, pending legal review, with BlackRock for investment in Long Treasuries. The investment will be staged incrementally over a period of months.

Tim reported that the private equity separate account contract with Pantheon was finalized by the end of August. TERS' external legal consultants, K&L Gates, worked hard to get specific items included in the contract that should benefit TERS over time.

Tim then presented an overview on Investment Management Fees.

New Business

TERS 2019-2020 Budget Update

Catherine Marx, Assistant Retirement Director, presented a mid-year TERS budget review using the Budget Status Report for the period ending June 30, 2019. With regard to the budgeted funds for Board education and training, the Board members requested an updated list of Educational Opportunities for 2020 – this will be included in the next Board packet.
