1. Call to Order; Roll Call

Clarissa Gines provided updates on the 2024-25 funding cycle, sharing that guidelines and applications are being updated and improved, with the goal of having them released by the end of January at the latest. She also shared that application workshops are scheduled, and encouraged TCAB members to attend. Clarissa Gines also mentioned that their partner Communities Rise is unable to provide application support this year, but that staff will be holding "drop-in conversations" to offer more accessible support for interested applicants.

Lisa Jaret then shared an update on Tacoma Creates' role as a community partner in the Beyond the Bell / Club B work, and announced a name change, going from "Office of Arts & Cultural Vitality" to "Arts & Cultural Vitality Division".

6. TCAB Committees & Operations

Lisa Jaret provided a quick update on the Division Manager recruitment process, and shared assignments for the 2024 panels and committees.

7. Conflict of Interest & Ethics Policy

Lisa Jaret walked through the Tacoma Creates' Conflict of Interest form, and the City's Code of Ethics with TCAB, to ensure that everyone's grounded in their understanding of these materials.
