1. Call to Order; Roll Call

With the two funding applications now closed, Clarissa Gines was able to share stats on how many applications were submitted. She also shared that all applications were screened for eligibility and completeness, and that funding panels were finalized and in process.

Lisa Jaret then covered what the panel process looks like, and prepped TCAB members for the voting process on funding recommendations, which will happen next month in two separate meetings.

Vice Chair Bert asked for a motion to approve the April 3<sup>rd</sup> meeting agenda, as well as the minutes from the March 6<sup>th</sup> meeting.

Lisa Jaret also shared some updates on the Impact Funding panel, along with updates on the Renewal Committee. She also noted that both the Operations and Recruitment Committees will be meeting soon.

Next, TCAB member Ellana Meas shared updates from on the conversation she had with Tacoma Creates staff about having some TCAB members attend a Mayor's Youth Commission of Tacoma meeting to share more about what TCAB and their work.

### 7. Action Item: Eligibility Committee

### TCAB member Megan Clark

TCAB member Megan Clark (representing the Eligibility Committee) talked through their process in determining seven applications which were deemed ineligible based on Tacoma Creates eligibility criteria, two applications which were deemed eligible for review, and some exceptions that were approved.

There was a motion, "Based on the work of the Eligibility Committee, I move that we approve the technical exceptions recommended by staff, that Earthy & Wise and Esperanza Mobil Family Resource Center are deemed eligible for review, that Entertainment Resource Alliance is ineligible for review based on their Location criteria, and that the following organizations are not eligible for review based on the Primary Purpose criteria: Downtown on the Go, Green Flag Foundation, Multicultural Child and Family Hope Center, Oasis of Hope, Tacoma United Association, and TEAM WRK."

TCAB member Allison Campbell asked staff, "Out of the [seven] applications that were deemed ineligible for funding based on that Primary Purpose criteria, what kind of contact did you have with them prior to their applications arriving?" Lisa Jaret shared that it was a mix – some organizations did contact staff, and some did not.

Co-Vice Chair Brian Robinson asked how many total Impact Funding applications will be moved forward for review, and Lisa shared that 49 applications will be reviewed.

### 8. Presentation: Tacoma Public Library

Lisa introduced Amita Lonial, Assistant Library Director of the Tacoma Public Library (TPL), who shared a presentation on the partnership work between TPL and Tacoma Creates. TCAB members shared questions and appreciation afterwards.

Clarissa Gines provided information on the upcoming Tacoma Poet Laureate – Pass the Torch event happening on Wednesday, April 12<sup>th</sup> at the Moore library branch.

## **10.** Comments from TCAB

Vice Chair Bert offered space for TCAB members to share any experiences they had with events put on by Tacoma Creates-supported organizations. TCAB member Roxane Hreha shared updates from two programs she engaged with.
