State of Emergency Proclamation in Regards to COVID - 19

Council voted on Tuesday to confirm the City of Tacoma's March 12 state of emergency proclamation in response to COVID-19.

The City's state of emergency proclamation was made in accordance with Tacoma Municipal Code Chapter 1.10. It allows the City to waive certain contracting and budget requirements, authorize staff to implement emergency purchasing requirements, and take other steps in response to the emergency.

As the City continues planning for a wide range of incidents and scenarios to ensure continuity of services for customers and community members, <u>Tacoma-Pierce County Health Department</u> <u>continues to provide updates on Pierce County residents who have received presumed positive test</u>

results for COVID-19 and the World Health Organization has officially categorized this outbreak as a pandemic.

At the recommendation of its Emergency Management Team and Tacoma-Pierce County Health Department, City facilities including administrative offices at the Tacoma Municipal Building complex (747 Market St. and 733 Market St.) closed to the public beginning at 7:30 a.m. on March 18, until further notice. Essential City services, including emergency services and solid waste collection services, remain operational.

The City of Tacoma is supporting our residents

The City of Tacoma is committed to supporting our residents during this emergency.

Pursuant to the City's state of emergency proclamation, Council required the City's power, water, sanitary sewer, storm water, and solid waste utilities to postpone shutoffs for non-payment. Council also adopted Resolution No. 40575 approving the creation of an Emergency Assistance Program by Tacoma Public Utilities to allow more households to qualify for assistance. The Emergency Assistance Program is funded for up to \$1 million. For payment plans and assistance, call 253-502-8600, or visit their website to learn more at <u>MyTPU.org/COVID19</u>.

I am committed to ensuring every person in Tacoma has a home. During this very stressful time for our community, the City is assessing if additional emergency renter protections are needed.

Tacoma Public Schools offering meals to all students

Governor Inslee ordered the closure of all schools in Washington state. Tacoma Public Schools are closed to allow for social distancing to reduce the spread of the coronavirus (COVID-19) in our community and state.

10 meals sites remain open to families: Tacoma Public School's 10 middle schools, including Gray and Baker, are serving as regional meal distribution sites for our students will remain open and staffed by Nutrition Services staff, security personnel and custodians. 

You Count: Why It's Important to Take the 2020 Census Survey



By now, you have probably received information from the U.S. Census Bureau about the 2020 Census survey. I know that much of our attention is focused on keeping our families healthy given the recent COVID-19 outbreak, but I would like to encourage you to take some time at home to complete the Census survey. The federal government uses Census data to make decisions on how \$675 billion in funding will be spent throughout the nation. This funding supports education, public health, transportation, and other programs and grants that the City of Tacoma relies on to serve the community. The data is also used as a basis for the boundaries of state legislative and

congressional districts. The Census is only conducted every 10 years, so this is our chance to be counted!

You can respond to the Census survey at this link, by filling out the form you received in the mail, or over the telephone. The Census survey does not ask about a person's citizenship status.
