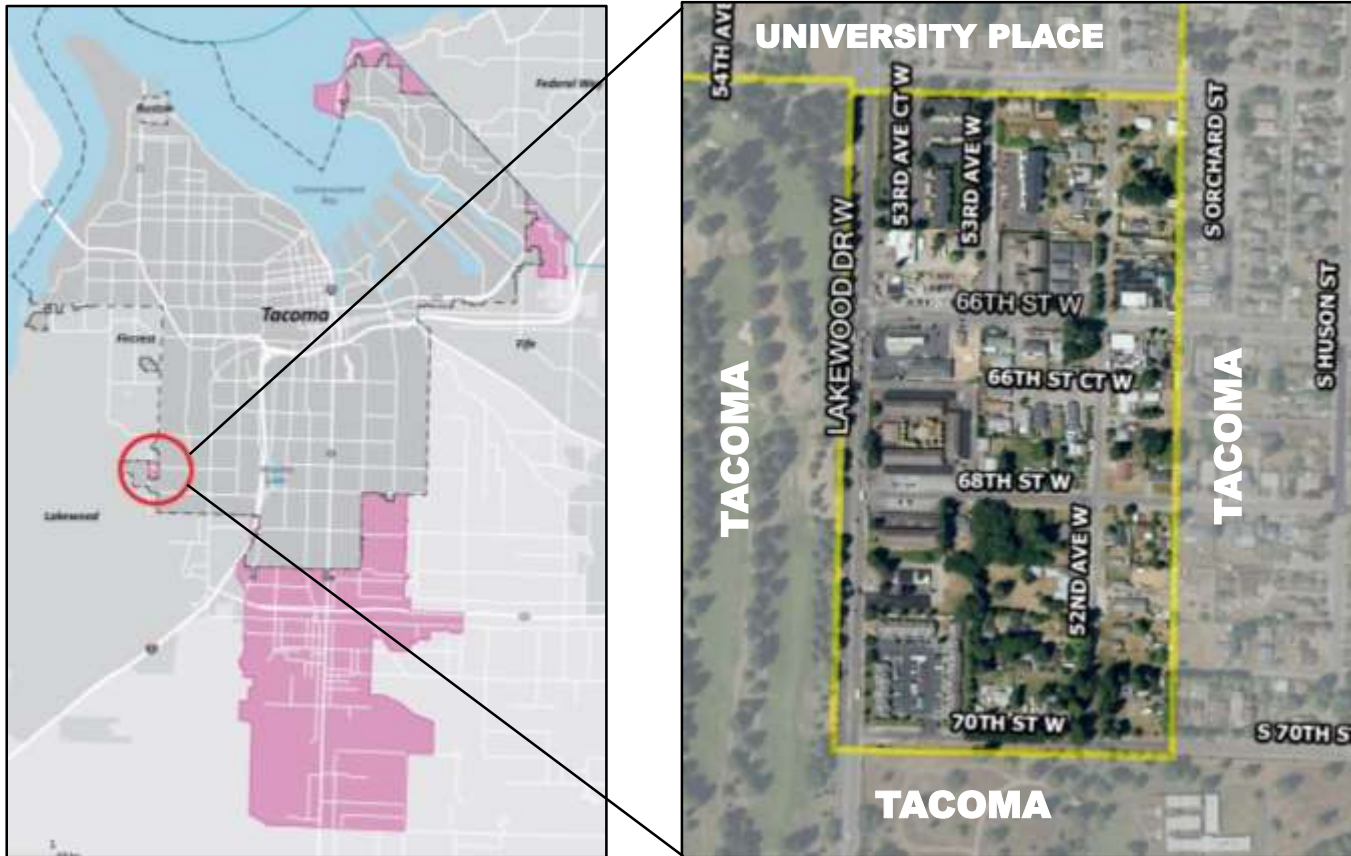


# Public Hearing Subject

# Manitou Potential Annexation Area

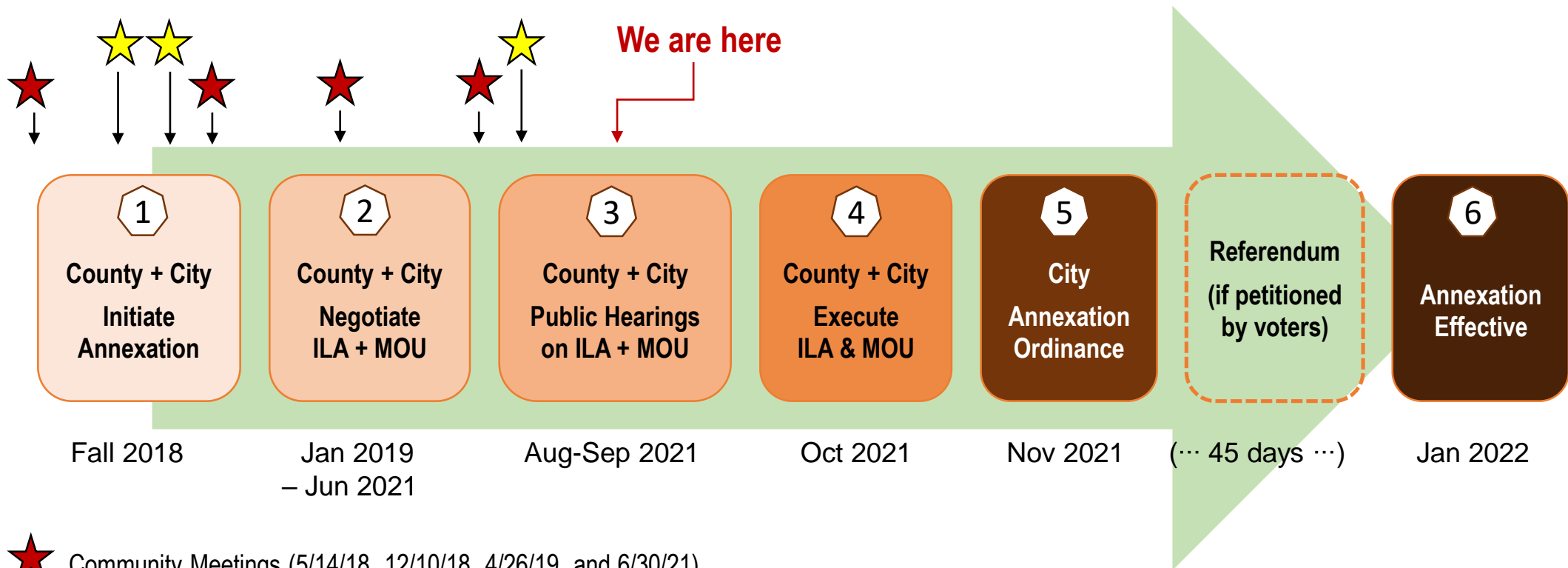

# ●●● Fiscal Impacts – City of Tacoma



- Revenues: \$131,200 annually
- Expenditures: Various
- Given the scale of the Manitou area, fiscal impacts are expected to be minimal and manageable.
- The City has the capacity and capability to provide the required services for the Manitou area.
