Project Scope: The City of Tacoma (City), Environmental Services Department is soliciting a Request for Proposal (RFP) from qualified firms to furnish labor, materials, equipment, and oversight to perform maintenance, repair, renovation and other mutually agreed upon work at the City of Tacoma Environmental Services managed facilities on an on-call basis. These facilities include the Solid Waste Recovery and Transfer Center (RTC) plus any off-site Solid Waste facilities including compactor sites and recycling drop off locations; the Central Wastewater Treatment Plant, North End Wastewater Treatment Plant and the various off-site pump stations associated with our sewage and storm collection systems.

Estimate: \$800,000
