Request for Bids Specification No. TR23-0037F Alexander Wye & Storage Track Upgrades

NOTICE TO ALL BIDDERS:

This addendum is issued to clarify, revise, add to or delete from, the original specification documents for the above project. This addendum, as integrated with the original specification documents, shall form the specification documents. The noted revisions shall take precedence over previously issued specification documents and shall become part of this contract.

REVISIONS TO THE SUBMITTAL DEADLINE:

The submittal deadline remains the same.

The following information provides a summary of changes made to the plans and specifications for this project.

REVISIONS TO THE SPECIAL PROVISIONS:

Change #1

8-31.1 Description

Replace Lines 37 through 43 on Page 69 with the following:

Switch Replacement and Removal:

The contractor shall remove and replace existing turnouts with new turnouts as specified. As called out within the project limits there are three #9 turnouts and one #7 turnout. This work shall include installing switch points, rail, frog, switch ties, switch stand, and OTM to construct a fully operational switch. Within the remove and replace switches section of this project, excavation, ballast, and raise, surface, line and dress are separate items.

Change #2

8-31.2(9) Description

Insert the following after the 3rd paragraph (line 12) on page 72:

Frog (non-EDH) shall be in accordance with 2014 AREMA Portfolio plan No. 622-09; No. 7 Rail Bound Manganese Steel Frog (13 foot) for 115RE HH Rail with screw spike plates, screw spikes and elastic fasteners. Frog shall be drilled for three (3) bolts to match the specified rail.

Answers to Questions Raised during the bid period:

1. Request for Information: Turnout Materials

Referencing the project specifications, on page 71, starting on line 39: **Section 8-31 8-31.2(9) Turnouts**

All rail, switch points (excluding tip), **frogs**, and guard rails shall be DOMESTIC, all other OTM may be foreign or domestic.

We are requesting that an exclusion for the domestic requirements be made for the manganese inserts in the frog. *The manganese inserts in the frog may be excluded.*

2. Request for Information: Tie Plates

Referencing the project specifications, on page 71, starting on line 23: 8-31.2(7) Tie Plates

In all tangent sections of track all tie plates **shall be new** and shall conform to A.R.E.M.A Plan 7 or 8 – "A.R.E.M.A. 14" tie plates for 5-1/2" wide rail base.

On previous projects Tacoma Rail has allowed the use of #1 Relay Tie plates in the areas of Rail Relay where standard cut spike tie plates are used.

Would Tacoma Rail allow the use relay tie plates in the Rail Relay areas of the project? *Please bid as specified.*

Project Scope: This project is primarily comprised of select tie replacement, select switch tie replacement, rail relay with pandrol plates, and replacement of four switches along Alexander Avenue.

Estimate: \$851,000
