- Question 2: Insurance. We cover General, Auto, and Workmans. We do not cover: **Employers' Liability Insurance, Excess or Umbrella Liability Insurance, Pollution Liability Insurance, Additional Insured**
- Answer 2: The insurance requirements were developed with our risk team following assessment of the scope of work. You are free to state exceptions to any part of the specifications. The City will be the sole judge of whether stated exceptions are acceptable and determination of the necessity of the stated coverages will be made during evaluation.
- Question 3: It appears the RFP Specification Document was updated today...is it possible to tell us whenever an update is done, where the change was made so we don't have to reread through 41 pages to find?
- Answer 3: Registering for the Bid Holder's List at tacomapurchasing.org will ensure your company is notified of any changes made to the specifications or associated documents.
