COOPERATIVE PURCHASING AGREEMENT

Pursuant to provisions of the law, City of Tacoma, hereinafter called "the City," and the following political subdivision of the State of Washington, hereinafter called the City of Mercer Island, hereby agree to cooperative purchasing upon the following terms and conditions;

1. The City, in negotiating for the purchase of goods and services for the City, agrees to extend the privileges of said negotiations to The City of Mercer Island to the extent permitted by law, and agreed upon the parties hereto, and the vendors.
2. The City of Mercer Island accepts responsibility of compliance with any additional or varying laws and regulations governing purchases by or on behalf of the City of Mercer Island. A purchase by the City of Mercer Island shall be effected by a purchase order directed to the vendor or other party contracting to furnish goods of services to The City.
3. The City accepts no responsibility for the performance of any purchasing contract by the vendor, and the City accepts no responsibility for payment of the purchase by the City of Mercer Island.
4. The City of Mercer Island assumes the responsibility of contracting independently for the purchase of any goods and services, with or without notice to the City.
5. This agreement is for goods and services necessary for City of Mercer Island operations and maintenance.
6. This agreement shall remain in force until cancelled by either party, which cancellation may be effected with or without notice to the other party.
7. This Agreement covers all City of Tacoma Contracts.
