A purchase by the City of Tacoma shall be effected by a purchase order directed to the vendor or other party contracting to furnish goods ~~or~~^{OR} services to The City.
3. The ~~County~~^{P.u.d.} accepts no responsibility for the performance of any purchasing contract by the vendor, and the ~~County~~^{P.u.d.} accepts no responsibility for payment of the purchase by the City of Tacoma.
4. The City of Tacoma assumes the responsibility of contracting independently for the purchase of any goods and services, with or without notice to the ~~County~~^{P.u.d.}.
5. This agreement is for goods and services necessary for City of Tacoma operations.
6. This agreement shall remain in force until cancelled by either party, which cancellation may be effected with or without notice to the other party.
7. This Agreement covers all Pacific County^{P.u.d.} Contracts.
