



## Legislation Passed November 4, 2014

The Tacoma City Council, at its regular City Council meeting of November 4, 2014, adopted the following resolutions and/or ordinances. ### **Resolution No. TBD 006**

A resolution setting Tuesday, November 18, 2014, and Tuesday, November 25, 2014, at approximately 5:30 p.m., as the dates for the first and second public hearings on the proposed 2015-2016 Transportation Benefit District Budget and Spending Plan.



## RESOLUTION NO. TBD006

1 A RESOLUTION relating to the City of Tacoma Transportation District; setting  
2 Tuesday, November 18, 2014, as the date for the first public hearing  
3 regarding the approval of the 2015-2016 Transportation Benefit District  
4 Budget/Spending Plan; and setting Tuesday, November 25, 2014, as the  
5 date for the second public hearing regarding the approval of the 2015-2016  
6 Transportation Benefit District Budget/Spending Plan.

7 WHEREAS RCW 35.21.225 and 36.73.020 provide for the establishment of  
8 a Transportation Benefit District ("TBD") by cities and counties to levy and impose  
9 various taxes and fees to generate revenue to support transportation  
10 improvements that benefit the district and are consistent with state, regional, or  
11 local transportation plans, and necessitated by existing or reasonably foreseeable  
12 congestion levels, and

13 WHEREAS Ordinance No. 28099, passed on November 20, 2012, and  
14 codified under Chapter 10.28 of the Tacoma Municipal Code, established a TBD  
15 for the purpose of acquiring, constructing, improving, providing, and funding  
16 transportation improvements within the district, and

17 WHEREAS, on November 27, 2012, the TBD Board authorized a vehicle  
18 license fee of \$20, and

19 WHEREAS the City's 2015-2016 Biennial Budget assumes \$4,792,894 in  
20 estimated TBD revenues for transportation improvements within the district, and

21 WHEREAS transportation projects may include the operation,  
22 preservation, and maintenance of transportation facilities or programs, and

WHEREAS a Budget/Spending Plan is necessary to outline the transportation improvements to be funded by the TBD, appropriate funds for said improvements, and coordinate with stakeholders and utilities; Now, Therefore,

BE IT RESOLVED BY THE GOVERNING BOARD OF THE TACOMA TRANSPORTATION BENEFIT DISTRICT:

Section 1. That the first public hearing on the 2015-2016 Transportation Benefit District Budget/Spending Plan shall be held before the Governing Board of the Tacoma Transportation Benefit District in the Council Chambers on the first floor of the Tacoma Municipal Building, 747 Market Street, Tacoma, Washington, on Tuesday, November 18, 2014, at approximately 5:30 p.m. or as soon thereafter as the same may be heard.

Section 2. That the second public hearing on the 2015-2016 Transportation Benefit District Budget/Spending Plan shall be held before the Governing Board of the Tacoma Transportation Benefit District in the Council Chambers on the first floor of the Tacoma Municipal Building, 747 Market Street, Tacoma, Washington, on Tuesday, November 25, 2014, at approximately 5:30 p.m. or as soon thereafter as the same may be heard.
