A resolution setting Tuesday, August 29, 2017, at approximately 5:15 p.m., as the date for the public hearing by the City Council, on the sale of approximately .30 acres of property, located at the southwest corner of 51st Street Northeast and Caledonia Road Northeast, in unincorporated Pierce County, to Jeff and Mary Norton, for the amount of \$160,000. 1 A RESOLUTION relating to utility-owned surplus property; setting Tuesday,
2 August 29, 2017, as the date for a public hearing on the sale of
3 approximately .30 acres (approximately 13,000 square feet) of property,
4 located at the southwest corner of 51st Street NE and Caledonia Road NE,
5 in unincorporated Pierce County, owned by the City of Tacoma, through its
6 Department of Public Utilities, Water Division, and now surplus to its needs,
7 to Jeff and Mary Norton for the sum of \$160,000.

8 WHEREAS the City of Tacoma, through its Department of Public Utilities,
9 Water Division (d.b.a. "Tacoma Water"), owns approximately .30 acres
10 (approximately 13,000 square feet) of real property located at the southwest
11 corner of 51st Street NE and Caledonia Road NE, in unincorporated Pierce
12 County, Washington ("Property"), and

13 WHEREAS the Property was part of Tacoma Water's 2001 acquisition of
14 the Hyada Mutual Service Company, and has remained vacant since that time,
15 and

16 WHEREAS Tacoma Water determined that the Property was not essential
17 for continued effective utility service, and declared it surplus in 2002, and

18 WHEREAS the Property is zoned single-family residential, as part of the
19 Browns Point/Dash Point Community Plan by Pierce County, and

20 WHEREAS the Property was offered for sale in July 2008 and March 2015,
21 via a sealed bid process, but did not sell, and

22 WHEREAS the Property remains on the City's surplus website, and was
23 recently listed with a real estate broker for the appraised value of \$160,000, and

WHEREAS Tacoma Water has negotiated an offer to sell the Property to Jeff and Mary Norton for \$160,000, and will reserve an easement in the north 10 feet of the Property, and

WHEREAS the sale proceeds will be used to offset the historical costs incurred to replace and upgrade the infrastructure included in the 2001 acquisition of the property, and

WHEREAS the proposed sale was approved by the Public Utility Board on August 9, 2017, pursuant to Resolution No. U-10948, and the transaction was forwarded to the City Council for a public hearing and final approval, and

WHEREAS, pursuant to RCW 35.94.040 and TMC 1.06.280, the City Council shall conduct a public hearing on the proposed sale of City-owned real property; Now, Therefore,

1 A RESOLUTION relating to the Director of Utilities; approving the reappointment
2 of William A. Gaines to the position of Director of Utilities for the period of
3 September 22, 2017, through December 2, 2017; and approving a
4 Transition and Separation Agreement.

5 WHEREAS Tacoma City Charter § 4.18 states that the Public Utility
6 "Board shall appoint, subject to confirmation by the City Council, a Director of
7 Utilities . . . ,” and

8 WHEREAS the Public Utility Board conducted its annual performance
9 reviews, and on June 21, 2017, passed Amended Motion 17-04 to reappoint
10 William A. Gaines as Director of Utilities, and

11 WHEREAS the City Council has not yet reconfirmed the reappointment
12 of Mr. Gaines, and Mr. Gaines and the Public Utility Board have not agreed to
13 terms for a successor compensation agreement to go into effect beyond
14 December 31, 2017, and

15 WHEREAS, during July 2017, Mr. Gaines notified the Public Utility Board
16 of his consideration of retirement from his current position, pursuant to the
17 provisions of the Tacoma Employees' Retirement System, and the Public Utility
18 Board desires to ensure an orderly leadership transition for the Department of
19 Public Utilities according to the provisions of a Transition and Separation
20 Agreement, attached hereto as Exhibit "A," and

21 WHEREAS, at a Special Utility Board meeting held on August 7, 2017,
22 pursuant to Utility Board Resolution No. U-10949, the Public Utility Board
23 approved the reappointment of Mr. Gaines to the position of Director of Utilities
24 for the period of September 22, 2017, through December 2, 2017; approved a

1 Transition and Separation Agreement; and repealed Amended Motion 17-04, all
2 pending confirmation by the City Council; Now, Therefore,

3 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

15 Charter § 4.17, utilize the services of the City's Human Resources Department
16 to immediately seek, retain, and coordinate the services of an individual or
17 organization with the necessary expertise to assist the Public Utility Board in
18 developing and conducting a nationwide search for the appointment of a new
19 Director of Public Utilities, with such search to begin as soon as possible.

7 University of Washington (“UW”) faculty, which enables local government to tap
8 into the talent and energy of UW faculty and students in order to create livable

11 way, while providing opportunities for students to learn through real-life problem
12 solving, and

13 WHEREAS UW has the expertise to develop specific, year-long
14 engagements with local communities, and seeks to promote research, education,
15 service, and public outreach related to the development of livable communities,
16 and

17 WHEREAS, in 2017, the City applied for and was selected as the 2017-2018
18 LCY Community Partner, and

19 WHEREAS the proposed agreement, in an amount not to exceed \$350,000,
20 will be in effect for one year, from September 2017 through September 2018, and
21 may be extended by mutual written agreement of the parties, and will allow for
22 approximately 30 projects throughout the City, relating to public health, urban
23 design, economic development, and community service, and

1 A RESOLUTION relating to the City of Tacoma, Department of Public Utilities, Light
2 Division, d.b.a. Tacoma Power (“Tacoma Power”); authorizing Tacoma
3 Power to accept a 20-year extension of the non-exclusive Franchise
4 Agreement with the City of Lakewood, to allow Tacoma Power to continue
5 serving electric customers within the City of Lakewood.

6 WHEREAS, in 1997, the City of Lakewood (“Lakewood”) granted a non-
7 exclusive Franchise Agreement (“Franchise”) to the City of Tacoma, Department of
8 Public Utilities, Light Division, d.b.a. Tacoma Power (“Tacoma Power”), for the
9 purpose of providing electric service for customers located within the City of
10 Lakewood, which is set to expire in October 2017, and

11 WHEREAS the existing Franchise provides for up to two, five-year
12 extensions; however, Tacoma Power and Lakewood agree that extending the term
13 of the Franchise to 20 years would be mutually beneficial and create more stability
14 for planning purposes, and

15 WHEREAS, on July 17, 2017, the Lakewood City Council approved
16 Ordinance No. 672, granting a 20-year Franchise extension to Tacoma Power for
17 continued operations within Lakewood, and

18 WHEREAS the administrative fee, assessed in lieu of permit and processing
19 fees, will be adjusted with this extension to match the Gross Earnings Tax rate
20 Tacoma Power pays to the City of Tacoma, and

21 WHEREAS the extension will also lengthen the notification time for
22 relocation of major utility infrastructure and remove a 2003 amendment allowing
23 Click! to extend into the Flett Creek Area, as this language is now included in the
24 2004 Click! franchise agreement with the City of Lakewood, and

WHEREAS, by adoption of Public Utility Board Resolution No. U-10945 on August 9, 2017, the Franchise was approved, pending confirmation from the City Council, and

1 BY REQUEST OF DEPUTY MAYOR THOMS AND COUNCIL MEMBER McCARTHY

2 A RESOLUTION relating to the Tacoma Fire Department; expressing the City
3 Council's legislative intent to fund 24-hour Tacoma Fire Department engine
4 staffing on the Tide Flats, until such time as Fire Station 5 can become fully
5 operational, allowing the City Manager to commence all necessary
6 implementation steps.

7 WHEREAS Fire Station 5, located at 3510 East 11th Street on the Tacoma
8 Tide Flats, has been inactive since 2007 due to budget constraints and the need
9 to prioritize services, and

10 WHEREAS the nearest fire station to the central Tide Flats is Engine 3 in
11 Northeast Tacoma, which is an estimated 4.7 minutes away, and it is in the best
12 interest of area businesses and surrounding residential community to strive
13 toward a shorter response time, and

14 WHEREAS planned and existing industrial development in the Tide Flats
15 demonstrate a need for enhanced public safety services for this crucial hub of
16 economic activity, as well as the surrounding community, and

17 WHEREAS the City plans to renovate Fire Station 5 during 2018 and bring
18 it back into operation in 2019, and

19 WHEREAS it is the City Council's intent that appropriate steps be taken to
20 mitigate the risk of a fire-related emergency for businesses and surrounding
21 neighborhoods and reduce response times in the Tide Flats area during the
22 renovation process by providing 24-hour engine coverage on the Tide Flats, and

24 WHEREAS funding sources are anticipated to include the recently awarded
25 Staffing for Adequate Fire and Emergency Response ("SAFER") grant from the
