## RESOLUTION NO. TBD 018

1 A RESOLUTION relating to the City of Tacoma Transportation District; setting  
2 Tuesday, October 27, 2020, at approximately 5:15 p.m., as the date for a  
3 public hearing on the proposed 2021-2022 Transportation Benefit District  
Budget and Spending Plan.

4 WHEREAS RCW 35.21.225 and 36.73.020, and City Ordinance No. 28099  
5 authorized the establishment of a Transportation Benefit District (“TBD”) for the  
6 purposes of acquiring, constructing, improving, providing, and funding  
7 transportation improvements within the TBD, consistent with any state, regional, or  
8 local transportation plans, and necessitated by existing or reasonably foreseeable  
9 congestion levels, and  
10

11 WHEREAS, on November 27, 2012, the TBD Governing Board (“Board”)  
12 adopted Resolution No. TBD 001 authorizing the collection of a vehicle license  
13 fee of \$20, and passage of I-976 in 2019 repealed the City’s authority to collect  
14 the vehicle license fee which generated approximately \$2,898,000 per year, and  
15

16 WHEREAS on July 14, 2015, the Board adopted Amended Resolution  
17 No. TBD 008 to place ballot measure Proposition No. 4, later referred to as  
18 Proposition A, on the ballot for the General Election, which authorized a sales  
19 tax increase of one tenth of one percent (0.1 percent) to fund street  
20 improvements was passed in the November 3, 2015, General Election, and  
21

22 WHEREAS the City’s Office of Management and Budget estimates the  
23 City will collect an estimated \$11,185,418 in TBD revenues for the 2021-2022  
24 biennium, and the total proposed Budget/Spending Plan is \$11,185,418, and

1           WHEREAS RCW 36.73.020 states that the Board shall consider the  
2 following criteria when selecting transportation improvements: (1) reduced risk  
3 of transportation facility failure and improved safety; (2) improved travel time;  
4 (3) improved air quality; (4) increases in daily and peak period trip capacity;  
5 (5) improved modal connectivity; (6) improved freight mobility; (7) cost-  
6 effectiveness of the investment; (8) optimal performance of the system  
7 through time; and (9) other criteria, as adopted by the governing body in  
8 Tacoma Municipal Code 10.28, and  
9  
10

11           WHEREAS a Budget/Spending Plan is necessary to outline the  
12 transportation improvements to be funded by the TBD, appropriate funds for  
13 said improvements, and coordinate with stakeholders and utilities; Now,  
14 Therefore,

15           BE IT RESOLVED BY THE GOVERNING BOARD OF THE TACOMA  
16 TRANSPORTATION BENEFIT DISTRICT:  
17

18           Section 1. That a public hearing on the 2021-2022 Transportation Benefit  
19 District Budget/Spending Plan shall be held before the Governing Board of the  
20 Tacoma Transportation Benefit District in the Council Chambers on the first floor of  
21 the Tacoma Municipal Building, 747 Market Street, Tacoma, Washington, unless  
22 the Governor's proclamation limiting in-person meetings is still in effect and then a  
23 call in option will be provided, on Tuesday, October 27, 2020, at approximately  
24 5:15 p.m. or as soon thereafter as the same may be heard.
