1 A RESOLUTION relating to the vacation of City right-of-way; setting Thursday,  
2 December 3, 2020, at 1:30 p.m., as the date for a hearing by the Hearing  
3 Examiner on the request to vacate a portion of East "K" Street, and alley,  
4 between East 26th Street and East Wiley Avenue, west of East "L" Street,  
for business development and expansion.

6 owners of more than two-thirds of the properties abutting the portion of East "K"  
7 Street, and alley, between East 26th Street and East Wiley Avenue, west of

18 PIERCE COUNTY, WASHINGTON, LYING SOUTHERLY OF  
19 EAST 26TH STREET, WEST OF EAST "L" STREET AND  
NORTHERLY OF A LINE BEGINNING AT A POINT ON THE  
WEST LINE OF SAID BLOCK 7735 32 FEET NORTH OF  
THE SOUTHWEST CORNER THEREOF TO A POINT ON  
THE EAST LINE SAID BLOCK 7733 15 FEET NORTH OF  
THE SOUTHEAST CORNER THEREOF.
