A resolution setting Tuesday, January 26, 2016, at approximately 5:30 p.m., as the date for a public hearing on adjustments to the 2015-2016 Transportation Benefit District Budget and Spending Plan. RESOLUTION NO. TBD 012

1 A RESOLUTION related to the Transportation Benefit District; setting January 26,
2 2016, as the date for a public hearing on adjustments to the 2015-2016
3 Transportation Benefit District Budget/Spending Plan, and directing the City
4 Clerk to prepare and circulate proper notices of the time, date, and place of
5 said hearing.

6 WHEREAS, as authorized by RCW 35.21.225 and 36.73.020, City of
7 Tacoma Ordinance No. 28099 established a Transportation Benefit District
8 ("TBD") for the purposes of acquiring, constructing, improving, providing and
9 funding transportation improvements within the TBD consistent with any state,
10 regional, or local transportation plans and necessitated by existing or
11 reasonably foreseeable congestion levels, and

12 WHEREAS, on December 1, 2015, the TBD Governing Board ("Board")
13 adopted Resolution No. TBD 011, modifying the Transportation Benefit District
14 Material Change Policy, and

15 WHEREAS, in accordance with the Transportation Benefit District
16 Material Change Policy, the Board is required to hold a public hearing in the
17 event an approved transportation improvement exceeds the adopted spending
18 plan by more than twenty percent (20%) as approved by the Board, and

19 WHEREAS, for the 2015-2016 biennium the adopted TBD
20 Budget/Spending Plan estimated \$5,292,894 in revenue and expenses, and

21 WHEREAS adjustment to the Budget/Spending Plan is required to
22 account for the additional revenue resulting from approval of TBD Proposition A
23 in November 2015, which approval resulted in approximately \$2,380,000 in
24 additional revenue in the TBD fund in 2016, bringing the total estimated TBD
25 revenue to \$7,672,894 for the 2015-2016 biennium, and

WHEREAS, additional funds will be used to resurface residential streets in accordance with Proposition A and the City's Comprehensive Transportation Improvement Program; Now, Therefore,

BE IT RESOLVED BY THE GOVERNING BOARD OF THE TACOMA TRANSPORTATION BENEFIT DISTRICT:

Section 1. That a hearing for the purpose of proposed adjustments to the 2015-2016 Transportation Benefit District Budget/Spending Plan shall commence on January 26, 2016, at approximately 5:30 p.m. in the City Council Chambers, First Floor, Tacoma Municipal Building, 747 Market Street, Tacoma, Washington.

Section 2. That the Clerk of the City of Tacoma shall give proper notice of the time and place of said hearing.
