RESOLUTION NO. TBD 014

1 A RESOLUTION related to the Transportation Benefit District; setting November 1,
2 2016, as the date for a public hearing on the 2017-2018 Transportation
3 Benefit District Budget/Spending Plan; and directing the City Clerk to
4 prepare and circulate proper notices of the time, date, and place of said
5 hearing.

6 WHEREAS, as authorized by RCW 35.21.225 and 36.73.020, City of
7 Tacoma Ordinance No. 28099 established a Transportation Benefit District
8 ("TBD") for the purposes of acquiring, constructing, improving, providing and
9 funding transportation improvements within the TBD consistent with any state,
10 regional, or local transportation plans and necessitated by existing or reasonably
11 foreseeable congestion levels, and

12 WHEREAS, for the 2017-2018 Biennium, the TBD will collect an estimated
13 total amount of \$15,845,790, consisting of \$5,368,000 from vehicle license fees
14 and \$10,477,790 from the sales tax increase of one-tenth of one percent, and

15 WHEREAS it is necessary to conduct a public hearing on the proposed
16 2017-2018 Transportation Benefit District Budget/Spending Plan prior to
17 adoption; Now, Therefore,

18 BE IT RESOLVED BY THE GOVERNING BOARD OF THE TACOMA
19 TRANSPORTATION BENEFIT DISTRICT:

20 Section 1. That a hearing for the purpose of proposed adjustments to the
21 2017-2018 Transportation Benefit District Budget/Spending Plan shall commence
22 on November 1, 2016, at approximately 5:15 p.m. in the City Council Chambers,
23 First Floor, Tacoma Municipal Building, 747 Market Street, Tacoma, Washington.
