Honorable Mayor Woodards and Distinguished Councilmembers,

The Tacoma Business Council is writing to share our concerns on the proposed increases in business license fees in Ordinance 28838 and Substitute Ordinance 28838. As currently written, neither ordinance is one we can support.

It is troubling to us that the City seeks to increase fees on business at a time when businesses are seeing reduced services and feel that our real concerns about property crime are going largely unaddressed. If fees must be increased at this time, we believe those fees should be directly invested in programs to address the largest issues plaguing businesses-crime and macroeconomic instability.

With regard to crime, we are all aware that the Tacoma Police Department is in triage mode due to their terribly low staffing levels. Despite the City's efforts, such as the lateral hiring bonus, which TBC applauds and supports, TPD's staffing problems will not be solved anytime soon. However, there are tools that the City could invest in that would enable TPD to do more with less. Technologies exist, like gun fire detection systems, that would help our police force be more effective in addressing violent crime. Investing in those technologies would have a dual benefit: it would help solve the murders we are suffering as a City and would free up police officers to begin focusing on property crime. All Tacomans, not just businesses, would benefit from that investment of the business community's money. Further, that approach would be more equitable to the business community. We want to partner with the City, not simply be required to fund the City's budget.

To be clear, TBC would support a reasonable license fee increase only so long as the funds used to buy technology were in addition and supplemental to TPD's existing budget request.

With regard to macroeconomic issues, businesses are suffering from over 8% inflation and working under the cloud of a pending recession. In this atmosphere, large fee increases appear to be more "piling on" by the City. We must point out that the size of the proposed increases in either ordinance far outweigh inflation. As such, inflation cannot be pointed to by the City as a justification for the size of the increases sought by these ordinances.

TBC wants to further address the substitute ordinance put forth by Councilmembers Blocker, Walker and Diaz. With the Substitute Ordinance, the Councilmembers would impose staggering fee increases. Blocker, Walker and Diaz seek a 127% increase in fees on small businesses that generate revenue between \$12,000 and \$250,000, a 128% fee increase for businesses between \$250,000 and \$1 million, a 700% increase for those between \$1M and \$5 M, and a 900% increase for those with revenue over \$5M. That is egregious and cannot be supported under any circumstances.

No member of the current council has experience owning a business and collectively you have very limited experience working in the private sector. As a result the Council may not be equipped to fully understand the challenges facing businesses. As a city we all benefit from a vibrant business community. Let's slow down the legislative process on this fee increase. Let's ensure that the increases are reasonable, that they invest in the community by being used to purchase technologies that enable TPD to be more efficient, and that the Ordinance includes language ensuring that these things happen. Let's work together to invest in the community-it will pay enormous dividends to all Tacomans if we do.

We appreciate the opportunity to weigh in. Thank you for your consideration.

Honorable Mayor Woodards and Tacoma City Council Members,

The Chamber wants to extend our sincere appreciation to the city staff and leadership for reaching out to our organization to discuss and review the proposal to increase the business license fees. We know the best way to create exceptional policy is to be inclusive and ensure all voices of impacted parties are part of the conversation when crafting policy. The Tacoma-Pierce County Chamber has strived to advocate for all businesses through leadership, advocacy, and building strong relationships. This includes partnering with other organizations and companies to offer new ways to support small business growth. We know we are stronger together and together is the only way we will really create economic equity and build generational wealth, with and for our community.

Unfortunately, our small businesses, particularly those owned by women and people of color, are now facing increased expenses as they recover from the pandemic. Those increased expenses include inflationary costs, workforce and labor cost increases, operational and facility costs due to crime and vandalism and now tax and fee increases proposed by the City of Tacoma.

The Chamber therefore would like to express our opposition to the proposal to increase business license fees as currently crafted. We understand the budget constraints the city is facing and are sympathetic to those constraints as all families and businesses in our region are facing the same constraints. As you evaluate modifications to the proposal, please consider the following suggestions:

- 1) Stair-Step Model. We encourage the city to consider a stair stepped approach to implementing the fee increases or pause for the next year. This will help guard against any budgetary concerns businesses may be facing.
- 2) Predictable Increases. A graduated business license fee increase model would help guard against inflationary concerns by planning for annual increases connected directly to the CPI that can be budgeted and predictable. It also helps guard against the large inflationary corrections that come with adjustments that only happen every 5-7 years.
- 3) Direct Investment in Economic Development and Public Safety. Investments made from the business community should help support the business community. Investments in technological tools such as a gun fire detection system, cameras, lighting, positive activation of public spaces through programming and events or assistance with crime prevention through environmental design are all examples of tools that have been used in communities, including ours with success, but do require investment of both capital and resources to implement. Other programs such as the window replacement program or other capital access grants and loans, all go a long way to help not only the business community, but our wider community, be more successful and engaged. Often a small loan of under \$10,000 can make a huge difference in enabling a business to thrive instead of just survive.



As businesses are still struggling with the impacts of the pandemic and face future economic uncertainty, knowing that any investment increase they contribute could be used for programs and/or initiatives that could both help their business or support our diverse economic ecosystem would be a positive step in continuing to build a more vibrant, strong and diverse local economy.

We need a robust, diverse and thriving business community to capitalize on our equitable economic development and workforce strategies and initiatives and need to do all we can to guard against displacement by keeping the costs of doing business low and competitive in our city.

Please feel free to reach out to me if I can help provide more context or be a resource. Again, we are grateful for our partnership and look forward to continuing to work in strong collaboration to benefit our community.

To whom it may concern,

My name is Kurando Honjo. I am a veterinarian working at Summit Veterinary Referral Center on 80th St. Ever since I've started there a year ago it was no news that the neighborhood, particularly that street, has been very unstable. Cars have caught on fire, gunshots are heard all the time, occupants of what is an encampment with knives and/or guns are seen brandishing them during conflicts among themselves. Just the other day one of our staff witnessed some folks running away and taking cover from gun fire. We have tried many times to contact police but no progress has been made. Occasionally the occupants of the street decrease in number but they come right back. Even if our staff witness a person with a weapon in front of our hospital, we have gotten responses such as if the witness is no longer there no one will come out to check on anything.

I am concerned about everyone involved. Our staff who feel fear going to and from their cars or even more so while they are serving the clients and animals we are all trying to help in our parking lot. A stray bullet at the very least is always a concern if not some sort of altercation or other unintended and unpleasant/uncomfortable interaction would always be on our minds. This is even worse for our night staff as we are a 24/7 facility.

I know its not these folks' fault necessarily that they cannot find better means of living. Costs of living skyrocket as wages stagger. Thats hard on everyone, especially for those without opportunity whatever circumstances they may face. I know or at least hope that someone with the capability - the authority and power with the willingness to work hard to approach these issues - as it cannot be an easy one by any means - is out there trying to find a solution to our collective problem to keep everyone involved safe, and housed. I feel as a community it is important to come together to take care of each other, and hope that there are policies in the works as a top priority to solve this crisis so Tacoma can evolve and thrive. Helping those in need has to be easier than constantly worrying about harm to others/themselves, watching as the problem gets worse and worse, and spending funds that can be directed toward figuring out housing and/or treatments for these folks than when dangerous situations result in incarceration, property damage, and at worst death.

We all hope something can be done.
