Climate Change Community Presentation Review - Emily Campbell, OEPS

Emily presented the draft climate change community presentation.

Commissioner comments included the following: look into and potentially include a newly created infographic by Pierce County; add a photo of the City's Wastewater Treatment Plant floodwall as an example of a City action; look into and potentially include the impacts on hydropower production; emphasize the vulnerabilities of the City's infrastructure; emphasize heat related health risks; conduct the concluding activity using an example of a City "behavior change" action; and this presentation may be best delivered by a pair of presenters.

Sustainability Small Grants and Green Events Preview – Emily Campbell, OEPS

Emily presented on the newly updated Sustainability Small Grant program and the Green Event & Environmental Services Event Support program. She presented the new webpages as well as the application materials.

Commissioners discussed the two programs and provided comment on minor improvements such as added web links and improved phrasing of questions on the Grant application. In light of the fact that Commissioners will be scoring grant applications and helping to determine awards, they acknowledged that they may be associated with organizations that may apply to the Grant program and thus should keep in mind conflicts of interest and seek guidance in the Commission's Rules of Procedure if needed.

TPU Director Community Input - Chair Lexi Brewer

Erica Tucci gave and overview of Tacoma Public Utilities' current process of collecting community input to inform the hiring of the new TPU Director. TPU is collecting responses to the following three questions: What do you like about Tacoma Public Utilities (TPU)? What do you not like about TPU? What questions would you like the Tacoma Public Utility Board and Tacoma City Council to ask the applicants for Utility Director?

Erica informed that comments should be submitted before TPU's January 10, 2018 Board meeting. Commissioners discussed these questions and, in response, created a list of questions and topics for TPU to consider. The Commission decided to provide their input in the form of a letter.

Motion: Chris Karnes motioned to empower Chrissy Cooley to compose a letter for submittal to the TPU Board before January 10th along the discussed themes as captured in the discussion. **Seconded by:** Todd Hay
